

 March 6, 2007 - Introduced by Senator ELLIS, cosponsored by Representative ROTH. Referred to Committee on Senate Organization.

1 **Relating to:** the life and military service of United States Army Pfc. Jon Bailey St.
2 John II.

3 Whereas, Jon was born on May 13, 1981, in Neenah, Wisconsin, and died on
4 January 27, 2007, of injuries sustained from enemy action in Taji, Iraq; and

5 Whereas, Jon was a 1999 graduate of St. Mary's Central High School in
6 Neenah, attended the University of Wisconsin-Fox Valley and the University of
7 Wisconsin-La Crosse, and enlisted in the United States Army in 2005; and

8 Whereas, Jon served with distinction in the United States Army 1st Cavalry
9 Division, Fort Hood, Texas, and was in his first tour of duty in Iraq; and

10 Whereas, Jon's family and fellow citizens are very proud of him and know that
11 he died doing what he wanted to do: serve the nation and fight for freedom; and

12 Whereas, Jon embodied the Army's core values of loyalty, duty, respect, selfless
13 service, honor, integrity, and personal service and he will be sorely missed; now,
14 therefore, be it
