

TO 2007 SENATE JOINT RESOLUTION 49**

May 9, 2007 - Offered by Senators Roessler and Sullivan.

\*\*\* AUTHORS SUBJECT TO CHANGE \*\*\*

1 At the locations indicated, amend the joint resolution as follows:

2 1. Page 2, line 11: delete "now, therefore, be it" and substitute "and".

3 ~~2.~~ Page 2, line 11: after that line insert:

4 "Whereas, Wisconsin Department of Veterans Affairs Secretary John A. Scocos  
5 first enlisted in the U.S. Army in 1979 and continues in the U.S. Army Reserves as  
6 a colonel serving as military assistant in the Office of the Secretary of the Army at  
7 the Pentagon; and

8 Whereas, John. A. Scocos first joined the Wisconsin Department of Veterans  
9 Affairs in 1997 as the department's executive assistant and served as executive  
10 assistant until 2001; and

11 Whereas, John A. Scocos served the legislature as a legislative assistant in the  
12 senate and as sergeant-at-arms and chief clerk of the assembly; and

1 Whereas, John A. Scocos rejoined the Wisconsin Department of Veterans  
2 Affairs as deputy secretary in 2002 and became secretary in 2003; and

3 Whereas, during his time as secretary, John A. Scocos worked with the  
4 legislature to create and develop the new Wisconsin GI bill, the VetEd program, the  
5 Wisconsin veterans and surviving spouses property tax credit, and numerous other  
6 programs that will assist veterans and their families throughout the state; and

7 Whereas, Secretary Scocos continues to provide a high level of quality service  
8 to both the legislature and veterans throughout the state and has earned the 2006  
9 Wisconsin State Department of the American Legion Leadership Medal, the 2006  
10 Wisconsin State Council of Vietnam Veterans of America Distinguished Service  
11 Award, and the 2006 Disabled American Veterans Distinguished Service Award,  
12 each of which is the highest award given by these organizations; and

13 Whereas, John is devoted to his wife, Kelly, and children, Chloe, Andreas, and  
14 Costa; now, therefore, be it”.

17 ~~4.~~ Page 2, line 14: after that line insert:

18 **“Resolved, That** the members of the Wisconsin legislature commend
