4 "SECTION 18e. Senate rule 41 (1) (a) is renumbered ~~Senate rule 41 (1) (a) 1.~~ and  
5 amended to read:

6 SENATE RULE 41 (1) (a) 1. ~~Subject to subd. 2.,~~ a proposal or other matter may  
7 be rereferred at any time prior to its passage, except that a motion to withdraw from  
8 committee may not take effect during the 7 days preceding any scheduled committee  
9 hearing meeting or the 7 days following the date on which a committee hearing  
10 meeting is held.

11 SECTION 18r. Senate rule 41 (1) (a) 2. is created to read:

12 SENATE RULE 41 (1) (a) 2. After the senate committee on organization  
13 establishes the calendar for a floorperiod, subd. 1. shall not apply to a motion made

1 during that floorperiod to withdraw a proposal or other matter from a committee if  
2 the committee schedules a meeting after the establishment of the calendar.”
