Submittal of County and Tribal Budgets

Current Language

Currently s. 46.40(14m) requires counties and tribal governing bodies to submit a proposed budget for the expenditures of Community Aids funding distributed under 46.45(2)(a) or carried forward under 46.45(3)(a) for the upcoming year to the Department of Health and Family Services (DHFS) by December 1st. The Department implemented this statutory requirement by developing the DCS 875 form for counties to complete and submit to DHFS by December 1st each year.

Proposed Change

Eliminate s. 46.40(14m).

Effect of the Change

Counties will no longer submit proposed budgets to DHFS on December 1.

Rationale for the Change

The elimination of the requirement will result in a reduction in workload for counties and tribes. DHFS has restructured data reporting requirements to gather consistent statewide expenditure data on an annual basis. Expenditure data more accurately reflects actual county costs than proposed budgets, so there is no longer a need for information on proposed budgets.
