**Appropriation Change to Allow Receipt of Federal Revenues from Department Facilities (DIN 2000, page 35)**

The department no longer receives funding from the federal government for the training of war orphans. This appropriation has been used to deposit and expend federal grant monies. The requested statutory change would allow the department to deposit and expend federal grant monies and revenue received from the federal VA for space it leases from the department in Wallace Hall at the Southern Wisconsin Center. The department does not currently have an appropriation that provides the needed authority being requested.

20.485 (2) (m) of the statutes is amended to read:

20.485 (2) (m) *Federal aid payments; veterans training-assistance.* All moneys received from the federal government for the education and training of war orphans assistance to veterans and their dependents to be expended for the purposes specified or for the use of department facilities to be expended for any purpose otherwise authorized under the statutes.
