

Repeal Real Estate Donation Provision

Current Language (as amended by 2005 Wisconsin Act 319)

48.982 (2e) (c) The corporation under par. (a) 1. shall donate any real property to the state within 5 years after acquiring the property unless holding the property for more than 5 years is consistent with sound business and financial practices and is approved by the joint committee on finance.

Proposed Change

Delete 48.982 (2e) (c)

Background and Rational for the Change

The Celebrate Children Foundation wants to avoid the possibility of potential donors finding it objectionable to have contributions turned over to the state.
