TITLE: REPEAL LOTTERY GPR APPROPRIATION

DESCRIPTION OF CURRENT LAW AND PROBLEM:

1999 Wisconsin Act 9 created GPR appropriations under s. 20.566(2)(am), (8)(a), (8)(b), and (8)(c) for the administration of certain Lottery activities during the 1999-01 biennium. The Governor's veto message vetoed the funding in the above appropriations for FY01 indicating that SEG funding for FY01 should be obtained by either separate legislation or through a s. 13.10 request. A s. 13.10 request was submitted to JCF for the April 2000 meeting and SEG base funding was authorized for appropriations s. 20.566(2)(r), (8)(q), (8)(r), and (8)(v) for FY01. 2001 Wisconsin Act 16 repealed s. 20.566(8)(a), (8)(b), and (8)(c). The GPR appropriation 20.566(2)(am) still exists in the agency's appropriation structure and needs to be removed.

RECOMMENDATION FOR ACTION:

Repeal the appropriation under s. 20.566(2)(am).
