HEALTH AND HUMAN SERVICES

MEDICAL ASSISTANCE

Under current law, DHFS administers the Medical Assistance (MA) program and the Badger Care health care program (BadgerCare), both of which provide health care benefits for eligible individuals. Individuals who may be eligible for MA, generally, are pregnant women, certain children, and elderly or disabled individuals, all of whom must meet specific low-income requirements. Families, children who do not reside with their parents, and unborn children whose mothers are not eligible for MA or BadgerCare may be eligible for BadgerCare if their incomes do not exceed 185 percent of the federal poverty line and they meet certain nonfinancial criteria, such as not having access to employer-subsidized health care coverage.

Waiver to implement BadgerCare Plus

Under this bill, DHFS must request a waiver from, and submit amendments to the state MA plan to, the secretary of the federal department of health and human services to allow DHFS to implement an MA health care program called BadgerCare Plus (BC+). BC+ would be financed as are other MA programs, partly with federal funds and partly with state funds. BC+ would replace all of BadgerCare and part of MA. Thus, individuals who satisfy eligibility criteria under both BC+ and BadgerCare would receive benefits under BC+. Individuals who satisfy eligibility

criteria under both BC+ and MA would receive benefits under either BC+ or MA, depending on the basis for their eligibility for MA. For example, an individual who is eligible for MA because he or she receives supplemental security income would continue to receive benefits as usual under MA rather than under BC+.

Benefits and general eligibility

BC+ would provide health care benefits to recipients under two different plans, depending on the basis for the recipient's eligibility. The first plan provides the same benefits that are provided under regular MA. Individuals eligible for BC+ benefits under that plan (regular MA plan) include: a pregnant woman whose family income does not exceed 200 percent of the poverty level (poverty); a child under one year of age whose mother, on the day on which the child was born, was eligible for and receiving benefits under MA or BC+ under the regular MA plan; any child whose family income does not exceed 200 percent of poverty; an individual whose family income does not exceed 200 percent of poverty and who is the parent or caretaker relative of a child who is, generally, living in the home of the parent or caretaker relative; certain migrant workers and their dependents; and an individual between 19 and 21 years of age who was in foster care on his or her 18th birthday.

The second plan, called the Benchmark Plan, provides specified benefits, including, but not limited to, coverage for prescription drugs; physicians' services; inpatient and outpatient hospital services; home health services; physical, occupational, and speech therapy; treatment for nervous and mental disorders and alcoholism and other drug abuse problems; durable medical equipment; and transportation to obtain emergency medical care. Individuals eligible for BC+ benefits under the Benchmark Plan include: a pregnant woman whose family income exceeds 200 percent, but does not exceed 300 percent, of poverty; a child under one year of age whose mother, on the day on which the child was born, was eligible for and receiving BC+ benefits under the Benchmark Plan; any child whose family income exceeds 200 percent, but does not exceed 300 percent, of poverty; and an individual whose family income exceeds 200 percent, but does not exceed 300 percent, of poverty and who is the parent or caretaker relative of a child who is, generally, living in the home of the parent or caretaker relative. In addition, any child whose family income exceeds 300 percent of poverty may purchase coverage under the Benchmark Plan at the full per member per month cost of the coverage.

For coverage under both the regular MA plan and the Benchmark Plan, a child is defined to include an unborn child whose mother is not eligible for MA or BC+ but satisfies all other eligibility criteria except that she is not a U.S. citizen or qualifying alien or is an inmate of a public institution. If the mother's family income does not exceed 200 percent of poverty, the unborn child is eligible for BC+ benefits, limited to prenatal care, under the regular MA plan; if the mother's family income exceeds 200 percent, but does not exceed 300 percent, of poverty, the unborn child is eligible for BC+ benefits, limited to prenatal care, under the Benchmark Plan.

Various other eligibility provisions apply under BC+. For example, regardless of any increase in income, a pregnant woman who is eligible for regular MA benefits remains eligible for those benefits until the last day of the month in which the 60th day after the last day of the pregnancy falls. A child who is receiving inpatient

services under the regular MA plan on the day before his or her 19th birthday remains eligible for those services until the end of the stay for which the services are being provided. A pregnant woman, a child, or a parent or caretaker relative whose family income is less than 150 percent of poverty is eligible for benefits for any of the three months before he or she applied for coverage if he or she was otherwise eligible and his or her family income was less than 150 percent of poverty.

Health insurance-related provisions

Various health insurance qualifications and limitations apply under BC+. As a condition of eligibility for BC+, an individual who is eligible for enrollment in a group health plan must apply for enrollment in that plan if DHFS determines that it is cost-effective. With exceptions for pregnant women, individuals in foster care on their 18th birthday, and certain children, no individual whose family income exceeds 150 percent of poverty is eligible for BC+ if the individual has health care coverage under the state employee health plan or coverage that is provided by an employer and for which the employer pays at least 80 percent of the premium. Regardless of family income, however, an unborn child is not eligible for BC+ if the unborn child or its mother has any type of health insurance coverage. Unless there is a good cause reason for not enrolling in the coverage, if an individual whose family income exceeds 150 percent of poverty or an unborn child or its mother had access in the 12 months before applying for BC+ to health care coverage under the state employee health plan or coverage that is provided by an employer and for which the employer pays at least 80 percent of the premium, the individual or unborn child is not eligible for BC+. A pregnant woman whose family income exceeds 200 percent of poverty and who has health insurance coverage must maintain that coverage as a condition of eligibility for BC+. If an individual whose family income exceeds 150 percent of poverty had coverage under the state employee health plan or employer-provided coverage but no longer has the coverage, if an unborn child or its mother had health insurance coverage but no longer has the coverage, or if a pregnant woman whose family income exceeds 200 percent of poverty did not maintain coverage that she had, the individual, unborn child, or pregnant woman is not eligible for BC+ for three calendar months following the month in which the coverage ended, unless there was a good cause reason for the termination of the coverage.

Under the bill, with certain exceptions, for an individual whose family income exceeds 150 percent of poverty, DHFS must verify directly with the employer, if any, whether the individual has or had insurance coverage or access. An employer that receives a request from DHFS for that information must supply the information within a certain time or pay a penalty equal to the full per member per month cost of coverage under BC+ for each month the individual is covered under BC+ until the employer provides the information. Penalties are limited to no more than \$1,000 in any six-month period for an employer with fewer than 250 employees, and to no more than \$15,000 in any six-month period for other employers.

Cost sharing

Generally, the same copayment requirements that apply under MA apply to BC+ recipients with benefits under the regular MA plan. BC+ recipients with

benefits under the Benchmark Plan are subject to the copayment and coinsurance requirements specified in the bill for that plan. A BC+ recipient who is an adult and who is not a pregnant woman must pay a premium for BC+ coverage if the recipient's family income is at least 150 percent of poverty. The premium may not exceed 5 percent of the recipient's family income. A BC+ recipient who is a child must pay a premium for BC+ coverage if the recipient's family income is at least 200 percent of poverty. The premium may not exceed the full per member per month cost of coverage for a child with a family income equal to 300 percent of poverty. A BC+ recipient who is an unborn child or a pregnant woman must pay a premium if the recipient's family income exceeds 200 percent of poverty. The premium may not exceed the full per member per month cost of coverage for an adult with a family income equal to 300 percent of poverty. If a recipient who is required to pay a premium does not pay it when it is due, the recipient's coverage terminates and the recipient may not be eligible for BC+ again for six months.

17 1, 1990, and who, on his or her 18th birthday, was in a foster care or treatment foster
18 care placement under the responsibility of a state, as determined by the department.
19 The coverage for an individual under this subdivision ends on the last day of the
20 month in which the individual becomes 21 years of age, unless he or she otherwise
21 loses eligibility sooner.

22 6. Migrant workers and their dependents who are determined eligible under
23 sub. (6) (f).

24 (b) Except as otherwise provided in this section, all of the following individuals
25 are eligible for the benefits described in sub. (11):

1 1. A pregnant woman whose family income exceeds 200 percent but does not
2 exceed 300 percent of the poverty line.

3 1m. A pregnant woman or unborn child who obtains eligibility under sub. (7)
4 (b) 1.

5 2. A child who is under one year of age, whose mother was determined to be
6 eligible under subd. 1., and who lives with his or her mother in this state.

7 3. A child whose family income exceeds 200 percent but does not exceed 300
8 percent of the poverty line. For a child under this subdivision who is an unborn child,
9 benefits are limited to prenatal care.

10 4. An individual who satisfies all of the following criteria:

11 a. The individual is a parent or caretaker relative of a child who is living in the
12 home with the parent or caretaker relative or who is temporarily absent from the
13 home for not more than 6 months or, if the child has been removed from the home for
14 more than 6 months, the parent or caretaker relative is working toward unifying the
15 family by complying with a permanency plan under s. 48.38.

16 b. The individual's family income includes self-employment income and does
17 not exceed 200 percent of the poverty line as calculated under sub. (7) (a) 3.

18 (c) Except as otherwise provided in this section, a child who is not an unborn
19 child and whose family income exceeds 300 percent of the poverty line is eligible to
20 purchase coverage of the benefits described in sub. (11), at the full per member per
21 month cost of the coverage.

22 **(5) PRESUMPTIVE ELIGIBILITY.** (a) In this subsection:

23 1. "Qualified entity" means an entity that satisfies the requirements under 42
24 USC 1396r-1a (b) (3) (A), as determined by the department.

1 2. "Qualified provider" means a provider that satisfies the requirements under
2 42 USC 1396r-1 (b) (2), as determined by the department.

3 (b) 1. Except as provided in sub. (6) (a), a pregnant woman is eligible for the
4 benefits specified in par. (c) during the period beginning on the day on which a
5 qualified provider determines, on the basis of preliminary information, that the
6 woman's family income does not exceed 300 percent of the poverty line and ending
7 on the applicable day specified in subd. 3.

8 2. Except as provided in sub. (6) (a), a child who is not an unborn child is eligible
9 for the benefits described in s. 49.46 (2) (a) and (b) during the period beginning on
10 the day on which a qualified entity determines, on the basis of preliminary
11 information, that the child's family income does not exceed 150 percent of the poverty
12 line and ending on the applicable day specified in subd. 3.

13 3. a. If the woman or child applies for benefits under sub. (4) within the time
14 required under par. (d), the benefits specified in subd. 1. or 2., whichever is
15 applicable, end on the day on which the department or the county department under
16 s. 46.215, 46.22, or 46.23 determines whether the woman or child is eligible for
17 benefits under sub. (4).

18 b. If the woman or child does not apply for benefits under sub. (4) within the
19 time required under par. (d), the benefits specified in subd. 1. or 2., whichever is
20 applicable, end on the last day of the month following the month in which the
21 provider or entity makes the determination under this paragraph.

22 (c) On behalf of a woman under par. (b) 1., the department shall audit and pay
23 allowable charges to a provider certified under s. 49.45 (2) (a) 11. only for ambulatory
24 prenatal care services under the benefits under sub. (11).

1 (d) A woman or child who is determined to be eligible under par. (b) shall apply
2 for benefits under sub. (4) on or before the last day of the month following the month
3 in which the qualified provider or entity makes the eligibility determination.

4 (e) A qualified provider or entity that determines that a woman or child is
5 eligible under par. (b) shall do all of the following:

6 1. Notify the department of that determination within 5 working days after the
7 day on which the determination is made.

8 2. Notify the woman or child of the requirement under par. (d) at the time of
9 the determination.

10 (f) The department shall provide qualified providers and qualified entities with
11 application forms for the benefits under sub. (4) and information on how to assist
12 women and children in completing the forms.

13 **(6) MISCELLANEOUS ELIGIBILITY AND BENEFIT PROVISIONS.** (a) Any pregnant
14 woman, including a pregnant woman under sub (5) (b) 1., child who is not an unborn
15 child, including a child under sub. (5) (b) 2., parent, or caretaker relative whose
16 family income is less than 150 percent of the poverty line is eligible for medical
17 assistance under this section for any of the 3 months prior to the month of application
18 if the individual met the eligibility criteria under this section and had a family
19 income of less than 150 percent of the poverty line in that month.

20 (b) A pregnant woman who is determined to be eligible for benefits under sub.
21 (4) remains eligible for benefits under sub. (4) for the balance of the pregnancy and
22 to the last day of the month in which the 60th day after the last day of the pregnancy
23 falls without regard to any change in the woman's family income.

24 (c) If a child who is eligible for benefits under sub. (4) is receiving inpatient
25 services covered under sub. (4) on the day before his or her 19th birthday and, but

1 for attaining 19 years of age, the child would remain eligible for benefits under sub.
2 (4), the child remains eligible for benefits until the end of the stay for which the
3 inpatient services are being furnished.

4 (d) If an application under this section shows that an individual is an essential
5 person, the individual shall be provided the benefits specified under sub. (4) (a) or
6 (b).

7 (e) The medical assistance eligibility extensions under s. 49.46 (1) (c), (cg), and
8 (co) for individuals who lose eligibility due to increased income do not apply to
9 BadgerCare Plus.

10 (f) The medical assistance eligibility provisions for migrant workers and their
11 dependents under s. 49.47 (4) (av) apply to BadgerCare Plus.

12 (g) 1. Except as provided in subd. 2., as a condition of eligibility for coverage
13 under this section, an individual with income shall provide verification, as
14 determined by the department, of that income.

15 2. Subdivision 1. does not apply to an individual under sub. (4) (a) 5. or a child
16 under the age of 18.

17 (h) Within 10 days after the change occurs, a recipient shall report to the
18 department any change that might affect his or her eligibility or any change that
19 might require premium payment by a recipient who was not required to pay
20 premiums before the change.

21 (i) For purposes of determining eligibility and family income, the department
22 shall include a family member who is temporarily absent from the home for not more
23 than 6 months, as determined by the department.

24 (j) All of the following apply to BadgerCare Plus in the same respect as they
25 apply under s. 49.46:

1 1. Section 49.46 (2) (c) and (cm), relating to benefits for individuals who are
2 eligible for Medicare.

3 2. Section 49.46 (2) (d), relating to prohibiting payments for any part of any
4 service payable through 3rd-party liability or any governmental or private benefit
5 system.

6 3. Section 49.46 (2) (dm), relating to prohibiting payment for services to
7 residents of institutions for mental diseases.

8 4. Section 49.46 (2) (f), relating to prohibiting payment for gastric bypass or
9 stapling surgery.

10 (k) For an individual who is eligible for medical assistance under this section
11 and who is eligible for coverage under Part D of Medicare under 42 USC 1395w-101
12 et seq., benefits under sub. (11) (a) or s. 49.46 (2) (b) 6. h. do not include payment for
13 any Part D drug, as defined in 42 CFR 423.100, regardless of whether the individual
14 is enrolled in Part D of Medicare or whether, if the individual is enrolled, his or her
15 Part D plan, as defined in 42 CFR 423.4, covers the Part D drug.

16 **(7) SPECIAL INCOME PROVISIONS.** (a) 1. In the calculation of family income, if an
17 adult member of the family has self-employment income, the department shall count
18 the net self-employment earnings. Net self-employment earnings shall be
19 determined by subtracting from gross self-employment income all self-employment
20 expenses that are allowed under federal and state tax law, except for depreciation.

21 2. If a parent's or caretaker relative's family income includes self-employment
22 income and, without deducting depreciation, does not exceed 200 percent of the
23 poverty line, the parent or caretaker relative is eligible under sub. (4) (a) 4.

1 3. If a parent's or caretaker relative's family income includes self-employment
2 income and, without deducting depreciation, exceeds 200 percent of the poverty line,
3 the parent or caretaker relative is eligible under sub. (4) (b) 4. if his or her family
4 income does not exceed 200 percent of the poverty line after depreciation is deducted.

5 (b) 1. A pregnant woman, or an unborn child, whose family income exceeds 300
6 percent of the poverty line may become eligible for coverage under this section if the
7 difference between the pregnant woman's or unborn child's family income and the
8 applicable income limit under sub. (4) (b) is obligated or expended for any member
9 of the pregnant woman's or unborn child's family for medical care or any other type
10 of remedial care recognized under state law or for personal health insurance
11 premiums or for both. Eligibility obtained under this subdivision continues without
12 regard to any change in family income for the balance of the pregnancy and, for a
13 pregnant woman but not for an unborn child, to the last day of the month in which
14 the 60th day after the last day of the woman's pregnancy falls. Eligibility obtained
15 by a pregnant woman under this subdivision extends to all pregnant women in the
16 pregnant woman's family.

17 2. A child who is not an unborn child and whose family income exceeds 150
18 percent of the poverty line may obtain eligibility under this section if the difference
19 between the child's family income and 150 percent of the poverty line is obligated or
20 expended on behalf of the child or any member of the child's family for medical care
21 or any other type of remedial care recognized under state law or for personal health
22 insurance premiums or for both. Eligibility obtained under this subdivision during
23 any 6-month period, as determined by the department, continues for the remainder
24 of the 6-month period and extends to all children in the family.

1 3. For a pregnant woman or an unborn child to obtain eligibility under subd.
2 1., the amount that must be obligated or expended in any 6-month period is equal
3 to the sum of the differences in each of those 6 months between the pregnant woman's
4 or unborn child's monthly family income and the monthly family income that is 300
5 percent of the poverty line. For a child to obtain eligibility under subd. 2., the amount
6 that must be obligated or expended in any 6-month period is equal to the sum of the
7 differences in each of those 6 months between the child's monthly family income and
8 the monthly family income that is 150 percent of the poverty line.

9 (c) When calculating an individual's family income, the department shall do all
10 of the following:

11 1. Deduct from family income any payments made by the individual for
12 court-ordered child or family support or maintenance.

13 2. Disregard earnings of children under 18 years of age.

14 3. Determine separately the family incomes of caretaker relatives and the
15 children for whom they are caring and not legally responsible.

16 4. Not include in the calculation any income of an individual receiving benefits
17 under s. 49.77 or federal Title XVI.

18 **(8) HEALTH INSURANCE COVERAGE AND ELIGIBILITY.** (a) 1. Except as provided in
19 subd. 2., any individual who is otherwise eligible under this section and who is
20 eligible for enrollment in a group health plan shall, as a condition of eligibility for
21 BadgerCare Plus and if the department determines that it is cost-effective to do so,
22 apply for enrollment in the group health plan, except that, for a minor, the parent
23 of the minor shall apply on the minor's behalf.

1 2. If a parent of a minor fails to enroll the minor in a group health plan in
2 accordance with subd. 1., the failure does not affect the minor's eligibility under this
3 section.

4 (b) Except as provided in pars. (c) and (d), an individual whose family income
5 exceeds 150 percent of the poverty line is not eligible for BadgerCare Plus if any of
6 the following applies:

7 1. The individual has individual or family health insurance coverage that is any
8 of the following:

9 a. Coverage provided by an employer and for which the employer pays at least
10 80 percent of the premium.

11 b. Coverage under the state employee health plan under s. 40.51 (6).

12 2. The individual, in the 12 months before applying, had access to the health
13 insurance coverage specified in subd. 1.

14 3. The individual could be covered under the health insurance coverage
15 specified in subd. 1. if the coverage is applied for, and the coverage could become
16 available to the individual in the month in which the individual applies for benefits
17 under this section or in any of the next 3 calendar months.

18 (c) An unborn child, regardless of family income, is not eligible for BadgerCare
19 Plus if any of the following applies:

20 1. The unborn child or the unborn child's mother has individual or family
21 health insurance coverage.

22 2. The unborn child or the unborn child's mother, in the 12 months before
23 applying, had access to the health insurance coverage specified in par. (b) 1.

24 3. The unborn child or the unborn child's mother could be covered under
25 individual or family health insurance coverage if the coverage is applied for, and the

1 coverage could become available to the unborn child or the unborn child's mother in
2 the month in which the unborn child applies for benefits under this section or in any
3 of the next 3 calendar months.

4 (d) 1. None of the following is ineligible for BadgerCare Plus by reason of having
5 health insurance coverage or access to health insurance coverage:

6 a. A pregnant woman.

7 b. A child described in sub. (4) (a) 2. or (b) 2.

8 c. Except as provided in par. (c), a child who has health insurance coverage, or
9 access to health insurance coverage, as a dependent of an absent parent but who
10 resides outside of the service area of the absent parent's plan.

11 d. An individual described in sub. (4) (a) 5.

12 e. A child who obtains eligibility under sub. (7) (b) 2., but only for the remainder
13 of the child's eligibility period under sub. (7) (b) 2.

14 2. An individual under par. (b) 2., or an individual who is an unborn child or
15 an unborn child's mother under par. (c) 2., is not ineligible if any of the following good
16 cause reasons is the reason that the individual did not obtain the health insurance
17 coverage under par. (b) 1. to which they had access:

18 a. The individual's employment ended.

19 b. The individual's employer discontinued health insurance coverage for all
20 employees.

21 c. One or more members of the individual's family were eligible for other health
22 insurance coverage or Medical Assistance at the time the employee failed to enroll
23 in the health insurance coverage under par. (b) 1. and no member of the family was
24 eligible for coverage under this section at that time.

1 d. The individual's access to health insurance coverage has ended due to the
2 death or change in marital status of the subscriber.

3 e. Any other reason that the department determines is a good cause reason.

4 (e) If a pregnant woman has health insurance coverage and her family income
5 exceeds 200 percent of the poverty line, the woman is required, as a condition of
6 eligibility, to maintain the health insurance coverage.

7 (f) If an individual with a family income that exceeds 150 percent of the poverty
8 line had the health insurance coverage specified in par. (b) 1. but no longer has the
9 coverage, if an individual who is an unborn child or an unborn child's mother,
10 regardless of family income, had health insurance coverage but no longer has the
11 coverage, or if a pregnant woman specified in par. (e) has health insurance coverage
12 and does not maintain the coverage, the individual or pregnant woman is not eligible
13 for BadgerCare Plus for the 3 calendar months following the month in which the
14 insurance coverage ended without a good cause reason specified in par. (g).

15 (g) Any of the following is a good cause reason for purposes of par. (f):

16 1. The individual or pregnant woman was covered by a group health plan that
17 was provided by a subscriber through his or her employer, and the subscriber's
18 employment ended for a reason other than voluntary termination, unless the
19 voluntary termination was a result of the incapacitation of the subscriber or because
20 on an immediate family member's health condition.

21 2. The individual or pregnant woman was covered by a group health plan that
22 was provided by a subscriber through his or her employer, the subscriber changed
23 employers, and the new employer does not offer health insurance coverage.

1 3. The individual or pregnant woman was covered by a group health plan that
2 was provided by a subscriber through his or her employer, and the subscriber's
3 employer discontinued health plan coverage for all employees.

4 4. The pregnant woman's coverage was continuation coverage and the
5 continuation coverage was exhausted in accordance with 29 CFR 2590.701-2 (4).

6 5. The individual's or pregnant woman's coverage terminated due to the death
7 or change in marital status of the subscriber.

8 6. Any other reason determined by the department to be a good cause reason.

9 **(9) EMPLOYER VERIFICATION OF INSURANCE COVERAGE.** (a) 1. Except as provided
10 in subd. 2., for an applicant or recipient with a family income that exceeds 150
11 percent of the poverty line, the department shall verify insurance coverage and
12 access information directly with the employer through which the applicant or
13 recipient may have health insurance coverage or access to coverage.

14 2. Subdivision 1. does not apply to any of the following:

15 a. A pregnant woman.

16 b. A child described in sub. (4) (a) 2. or (b) 2.

17 c. An individual described in sub. (4) (a) 5.

18 (b) An employer that receives a request from the department for insurance
19 coverage and access to coverage information shall supply the information requested
20 by the department in the format specified by the department within 30 calendar days
21 after receiving the request.

22 (c) 1. Subject to subds. 2. and 3., an employer that does not comply with the
23 requirements under par. (b) shall be required to pay, within 45 days after the
24 requested information was due, a penalty equal to the full per member per month
25 cost of coverage under BadgerCare Plus for the individual about whom the

1 information is requested, and for each of the individual's family members with
2 coverage under BadgerCare Plus, for each month in which the individual and the
3 individual's family members are covered before the employer provides the
4 information.

5 2. An employer with fewer than 250 employees may not be required to pay more
6 than \$1,000 in penalties under this paragraph that are attributable to any 6-month
7 period. An employer with 250 or more employees may not be required to pay more
8 than \$15,000 in penalties under this paragraph that are attributable to any 6-month
9 period.

10 3. Notwithstanding subd. 1., an employer shall not be subject to any penalties
11 if the employer, at least once per year, timely provides to the department, in the
12 manner and format specified by the department, information from which the
13 department may determine whether the employer provides its employees with
14 access to health insurance coverage.

15 4. All penalty assessments collected under this paragraph shall be credited to
16 the appropriation accounts under s. 20.435 (4) (jw) and (jz).

17 (d) An employer may contest a penalty assessment under par. (c) by sending
18 a written request for hearing to the division of hearings and appeals in the
19 department of administration. Proceedings before the division are governed by ch.
20 227.

21 **(10) COST SHARING.** (a) *Copayments.* Except as provided in s. 49.45 (18) (am),
22 all cost-sharing provisions under s. 49.45 (18) apply to a recipient with coverage of
23 the benefits described in s. 49.46 (2) (a) and (b) to the same extent as they apply to
24 a person eligible for medical assistance under s. 49.46, 49.468, or 49.47.

1 (b) *Premiums.* 1. Except as provided in subd. 4., a recipient who is an adult,
2 who is not a pregnant woman, and whose family income is greater than 150 percent
3 but not greater than 200 percent of the poverty line shall pay a premium for coverage
4 under BadgerCare Plus that does not exceed 5 percent of his or her family income.
5 If the recipient has self-employment income and is eligible under sub. (4) (b) 4., the
6 premium may not exceed 5 percent of family income calculated before depreciation
7 was deducted.

8 2. Except as provided in subds. 3. and 4., a recipient who is a child whose family
9 income is greater than 200 percent of the poverty line shall pay a premium for
10 coverage of the benefits described in sub. (11) that does not exceed the full per
11 member per month cost of coverage for a child with a family income of 300 percent
12 of the poverty line.

13 3. Except as provided in subd. 4., a recipient who is an unborn child, or a
14 pregnant woman eligible under sub. (4) (b) 1., whose family income is greater than
15 200 percent of the poverty line shall pay a premium for coverage of the benefits
16 described in sub. (11) that does not exceed the full per member per month cost of
17 coverage for an adult with a family income of 300 percent of the poverty line.

18 4. None of the following shall pay a premium:

19 a. A child who is a Native American or an Alaskan Native with a family income
20 that does not exceed 300 percent of the poverty line.

21 b. A child who is eligible under sub. (4) (a) 2. or (b) 2.

22 c. A child whose family income does not exceed 200 percent of the poverty line.

23 d. A pregnant woman whose family income does not exceed 200 percent of the
24 poverty line.

25 e. A child who obtains eligibility under sub. (7) (b) 2.

1 f. An individual who is eligible under sub. (4) (a) 5.

2 5. If a recipient who is required to pay a premium under this paragraph or
3 under sub. (4) (c) does not pay a premium when due, the recipient's coverage
4 terminates and the recipient is not eligible for BadgerCare Plus for 6 calendar
5 months following the date on which the recipient's coverage terminated.

6 **(11) BENCHMARK PLAN BENEFITS AND COPAYMENTS.** Recipients who are not eligible
7 for the benefits described in s. 49.46 (2) (a) and (b) shall have coverage of the following
8 benefits and pay the following copayments:

9 (a) Subject to sub. (6) (k), prescription drugs bearing only a generic name, as
10 defined in s. 450.12 (1) (b), with a copayment of no more than \$5 per prescription, and
11 subject to the Badger Rx Gold program discounts.

12 (b) Physicians' services, including one annual routine physical examination,
13 with a copayment of no more than \$15 per visit.

14 (c) Inpatient hospital services as medically necessary, subject to coinsurance
15 payment per inpatient stay of no more than 10 percent of the allowable payment
16 rates under s. 49.46 (2) for the services provided and a copayment of no more than
17 \$50 per admission for psychiatric services.

18 (d) Outpatient hospital services, subject to coinsurance payment of no more
19 than 10 percent of the allowable payment rates under s. 49.46 (2) for the services
20 provided, except that use of emergency room services for treatment of a condition
21 that is not an emergency medical condition, as defined in s. 632.85 (1) (a), shall
22 require a copayment of no more than \$75.

23 (e) Laboratory and X-ray services, including mammography.

24 (f) Home health services, limited to 60 visits per year.

1 (g) Skilled nursing home services, limited to 30 days per year, and subject to
2 coinsurance payment of no more than 10 percent of the allowable payment rates
3 under s. 49.46 (2) for the services provided.

4 (h) Inpatient rehabilitation services, limited to 60 days per year, and subject
5 to coinsurance payment of no more than 10 percent of the allowable payment rates
6 under s. 49.46 (2) for the services provided.

7 (i) Physical, occupational, speech, and pulmonary therapy, limited to 20 visits
8 per year for each type of therapy, and subject to coinsurance payment of no more than
9 10 percent of the allowable payment rates under s. 49.46 (2) for the services provided.

10 (j) Cardiac rehabilitation, limited to 36 visits per year and subject to
11 coinsurance payment of no more than 10 percent of the allowable payment rates
12 under s. 49.46 (2) for the services provided.

13 (k) Inpatient, outpatient, and transitional treatment for nervous or mental
14 disorders and alcoholism and other drug abuse problems, with a copayment of no
15 more than \$15 per visit and coverage limits that are the same as those under the state
16 employee health plan under s. 40.51 (6).

17 (L) Durable medical equipment, limited to \$2,500 per year, and subject to
18 coinsurance payment of no more than 10 percent of the allowable payment rates
19 under s. 49.46 (2) for the articles provided.

20 (m) Transportation to obtain emergency medical care only, as medically
21 necessary, and subject to coinsurance payment of no more than 10 percent of the
22 allowable payment rates under s. 49.46 (2) for the services provided.

23 (n) One refractive eye examination every 2 years, with a copayment of no more
24 than \$15 per visit.

1 (o) Fifty percent of allowable charges for preventive and basic dental services,
2 including services for accidental injury and for the diagnosis and treatment of
3 temporomandibular disorders. The coverage under this paragraph is limited to \$750
4 per year, applies only to pregnant women and children under 19 years of age, and
5 requires an annual deductible of \$200 and a copayment of no more than \$15 per visit.

6 (p) Early childhood developmental services, for children under 6 years of age.

7 (q) Smoking cessation treatment, for pregnant women only.

8 (r) Prenatal care coordination, for pregnant women at high risk only.

9 **(11m) PROVIDER PAYMENTS AND REQUIREMENTS.** The provider of a service or
10 equipment under sub. (11) shall collect the specified or allowable copayment or
11 coinsurance, unless the provider determines that the cost of collecting the copayment
12 or coinsurance exceeds the amount to be collected. The department shall reduce
13 payments for services or equipment under sub. (11) by the amount of the specified
14 or allowable copayment or coinsurance. A provider may deny care or services or
15 equipment under sub. (11) if the recipient does not pay the specified or allowable
16 copayment or coinsurance. If a provider provides care or services or equipment
17 under sub. (11) to a recipient who is unable to share costs as specified in sub. (11),
18 the recipient is not relieved of liability for those costs.

19 **(12) RULES; NOTICE OF EFFECTIVE DATE.** (a) 1. The department may promulgate
20 any rules necessary for and consistent with its administrative responsibilities under
21 this section, including additional eligibility criteria.

22 2. The department may promulgate emergency rules under s. 227.24 for the
23 administration of this section for the period before the effective date of any
24 permanent rules promulgated under subd. 1., but not to exceed the period authorized
25 under s. 227.24 (1) (c) and (2). Notwithstanding s. 227.24 (1) (a), (2) (b), and (3), the

1 department is not required to provide evidence that promulgating a rule under this
2 subdivision as an emergency rule is necessary for the preservation of the public
3 peace, health, safety, or welfare and is not required to provide a finding of emergency
4 for a rule promulgated under this subdivision.
