Differential State Share of Funding for the Milwaukee Parental Choice Program

Please modify s. 121.08 (4)(b) to change the reduction to MPS' school aid as follows:

- 45% of the MPCP costs for the cost of pupils up to 15,000
- 0% of the MPCP costs for the cost of pupils over 15,000

The result is that the state would continue to fund the current law share of 55% for all pupils enrolled in the program up to 15,000 pupils, but 100% of the program costs for all pupils enrolled in the program above 15,000 pupils.

Please make this change effective for the 2007-08 school year.

We'd like to keep this on a separate track from the initial drafting request on MPCP funding (LRB draft 07-0439).

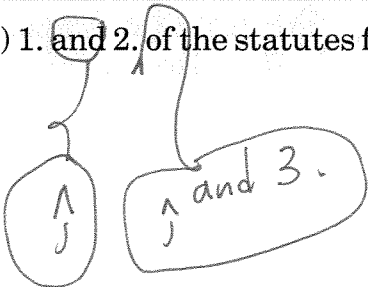
