5 the manner determined by the department. Except as provided in s. 84.075, the
6 contract shall be awarded to the lowest competent and responsible bidder as
7 determined by the department. If the bid of the lowest competent bidder is
8 determined by the department to be in excess of the estimated reasonable value of
