



1 **SECTION 9119. Nonstatutory provisions; Governor.**

2 (1d) POLICY DEVELOPMENT AND IMPLEMENTATION. The authorized FTE positions
3 for the office of the governor, funded from the appropriation under section 20.525 (1)
4 (a) of the statutes, are decreased by 4.0 GPR positions for the purpose of assisting in
5 the development and implementation of policy initiatives in that office.

6 **SECTION 9120. Nonstatutory provisions; Health and Educational**
7 **Facilities Authority.**

8 **SECTION 9121. Nonstatutory provisions; Health and Family Services.**

9 (1) BED ASSESSMENT FOR INTERMEDIATE CARE FACILITIES FOR THE MENTALLY
10 RETARDED. Notwithstanding section 50.14 (2m) of the statutes, as created by this act,
11 the department of health and family services is not required to calculate the amount
12 of the bed assessment for intermediate care facilities for the mentally retarded under
13 section 50.14 (2) (bm) of the statutes, as created by this act, for state fiscal year
14 2007-08 until October 1, 2007, or the first day of the 3rd month beginning after the
15 effective date of this subsection, whichever is later.

16 (1t) INDIAN CHILD HIGH-COST OUT-OF-HOME CARE PLACEMENT FUNDING. From the
17 appropriation account under section 20.435 (3) (kz) of the statutes, in fiscal year
18 2007-08 the department of health and family services may expend not more than
19 \$500,000 in moneys transferred from the appropriation account under section 20.505
20 (8) (hm) 21. ^{of the statutes, as created by this act,} for unexpected or unusually high-cost out-of-home care placements of
21 Indian children by tribal courts.

22 (5) TRANSFER TO THE DEPARTMENT OF CHILDREN AND FAMILIES.

23 (a) *Assets and liabilities.* On the effective date of this paragraph, the assets and
24 liabilities of the department of health and family services that are primarily related
25 to the functions of the division of children and family services in that department,

1 to the child abuse and neglect prevention program under section 46.515, 2005 stats.,
2 to the food distribution and hunger prevention programs under section 46.75, 2005
3 stats., section 46.76, 2005 stats., and section 46.77, 2005 stats., and to the state
4 supplemental food program under section 253.06, 2005 stats., as determined by the
5 secretary of administration, shall become the assets and liabilities of the department
6 of children and families.

7 (b) *Employee transfers.*

8 1. The classified positions, and incumbent employees holding positions, in the
9 department of health and family services relating primarily to the functions of the
10 division of children and family services in that department, to the child abuse and
11 neglect prevention program under section 46.515, 2005 stats., to the food
12 distribution and hunger prevention programs under section 46.75, 2005 stats.,
13 section 46.76, 2005 stats., and section 46.77, 2005 stats., and to the state
14 supplemental food program under section 253.06, 2005 stats., as determined by the
15 secretary of administration, are transferred to the department of children and
16 families.

17 2. The classified positions, and incumbent employees holding positions, in the
18 department of health and family services relating primarily to general
19 administration and program support that the secretary of administration
20 determines should be transferred to the department of children and families are
21 transferred to that department. Upon determination of these employees, the
22 secretary of health and family services shall, by January 1, 2008, and in conjunction
23 with the secretary of workforce development, submit a plan to the secretary of
24 administration requesting the transfer of moneys between the general purpose
25 revenue appropriations for the departments of health and family services and

1 workforce development and the department of children and families, between the
2 program revenue appropriations for the departments of health and family services
3 and workforce development and the department of children and families, between
4 the program revenue-service appropriations for the departments of health and
5 family services and workforce development and the department of children and
6 families, between the appropriations of given segregated funds for the departments
7 of health and family services and workforce development and the department of
8 children and families, and between the federal revenue appropriations for the
9 departments of health and family services and workforce development and the
10 department of children and families, if necessary to adjust previously allocated costs
11 in accordance with the transfer of personnel.

12 (c) *Employee status.* Employees transferred under paragraph (b) shall have the
13 same rights and status under subchapter V of chapter 111 and chapter 230 of the
14 statutes ^{§ as affected by this act} in the department of children and families that they enjoyed in the
15 department of health and family services immediately before the transfer.
16 Notwithstanding section 230.28 (4) of the statutes, no employee so transferred who
17 has attained permanent status in class is required to serve a probationary period.

18 (d) *Tangible personal property.* On the effective date of this paragraph, all
19 tangible personal property, including records, of the department of health and family
20 services that is primarily related to the functions of the division of children and
21 family services in that department, to the child abuse and neglect prevention
22 program under section 46.515, 2005 stats., to the food distribution and hunger
23 prevention programs under section 46.75, 2005 stats., section 46.76, 2005 stats., and
24 section 46.77, 2005 stats., and to the state supplemental food program under section

1 253.06, 2005 stats., as determined by the secretary of administration, shall be
2 transferred to the department of children and families.

3 (e) *Contracts*. All contracts entered into by the department of health and family
4 services in effect on the effective date of this paragraph that are primarily related
5 to the functions of the division of children and family services in that department,
6 to the child abuse and neglect prevention program under section 46.515, 2005 stats.,
7 to the food distribution and hunger prevention programs under section 46.75, 2005
8 stats., section 46.76, 2005 stats., and section 46.77, 2005 stats., and to the state
9 supplemental food program under section 253.06, 2005 stats., as determined by the
10 secretary of administration, remain in effect and are transferred to the department
11 of children and families. The department of children and families shall carry out any
12 such contractual obligations unless modified or rescinded by the department of
13 children and families to the extent allowed under the contract.

14 (em) *Pending matters*. Any matter pending with the department of health and
15 family services on the effective date of this paragraph that is primarily related to the
16 functions of the division of children and family services in that department, to the
17 child abuse and neglect prevention program under section 46.515, 2005 stats., to the
18 food distribution and hunger prevention programs under section 46.75, 2005 stats.,
19 section 46.76, 2005 stats., and section 46.77, 2005 stats., and to the state
20 supplemental food program under section 253.06, 2005 stats., as determined by the
21 secretary of administration, is transferred to the department of children and families
22 and all materials submitted to or actions taken by the department of health and
23 family services with respect to the pending matter are considered as having been
24 submitted to or taken by the department of children and families.

1 (f) *Rules and orders.* All rules promulgated by the department of health and
2 family services that are primarily related to the functions of the division of children
3 and family services in that department, to the child abuse and neglect prevention
4 program under section 46.515, 2005 stats., to the food distribution and hunger
5 prevention programs under section 46.75, 2005 stats., section 46.76, 2005 stats., and
6 section 46.77, 2005 stats., and to the state supplemental food program under section
7 253.06, 2005 stats., as determined by the secretary of administration, and that are
8 in effect on the effective date of this paragraph remain in effect until their specified
9 expiration dates or until amended or repealed by the department of children and
10 families. All orders issued by the department of health and family services that are
11 primarily related to the functions of the division of children and family services in
12 that department, to the child abuse and neglect prevention program under section
13 46.515, 2005 stats., to the food distribution and hunger prevention programs under
14 section 46.75, 2005 stats., section 46.76, 2005 stats., and section 46.77, 2005 stats.,
15 and to the state supplemental food program under section 253.06, 2005 stats., as
16 determined by the secretary of administration, and that are in effect on the effective
17 date of this paragraph remain in effect until their specified expiration dates or until
18 modified or rescinded by the department of children and families.

19 (6) AGENCY NAME CHANGE.

20 (a) Wherever the term "health and family services" appears in the statutes, as
21 affected by the acts of 2007, the term "health services" is substituted.

22 (b) Beginning on July 1, 2008, the department of health services has the powers
23 and duties granted or assigned the department of health and family services by
24 SECTIONS 9101 to 9155 of this act that do not terminate before paragraph (a) takes
25 effect. Beginning on July 1, 2008, the secretary of health services has the powers and

1 duties granted or assigned the secretary of health and family services by SECTIONS
2 9101 to 9155 of this act that do not terminate before paragraph (a) takes effect.

3 (6d) REDUCING FETAL AND INFANT MORTALITY AND MORBIDITY.

4 (a) In this subsection, "infant" means a child from birth to 12 months of age.

5 (b) In a county with a population of at least 190,000 but less than 230,000, from
6 the appropriation under section 20.435 (5) (eu) of the statutes, as created by this act,
7 the department of health and family services shall distribute \$250,000 in each of
8 state fiscal years 2007-08 and 2008-09 to the city health department to provide a
9 program of services to reduce fetal and infant mortality and morbidity.

10 (c) Notwithstanding section 251.08 of the statutes, in implementing the
11 program under paragraph (b), the city health department shall, directly or by
12 contract, do all of the following in or on behalf of areas of the county that are
13 encompassed by the zip codes 53402 to 53406 and that are at risk for high fetal and
14 infant mortality and morbidity, as determined by the department of health and
15 family services:

16 1. Collaborate with faculty in the health disciplines of an academic institution
17 and with a hospital that serves significant populations at high risk for poor birth
18 outcomes, including low birth weights, prematurity, and gestational diabetes, to
19 identify and implement best practices and evidence-based practices to reduce fetal
20 and infant mortality and morbidity.

21 2. Identify necessary preconception, prenatal, and postnatal services and
22 assess the availability of these services for women in the areas who lack insurance
23 coverage or who are recipients of the Medical Assistance program or the Badger Care
24 health care program.

1 3. Develop and implement models of care for all women in the areas who meet
2 risk criteria, as specified by the department of health and family services, and
3 provide comprehensive prenatal and postnatal care coordination and other services,
4 including home visits, by registered nurses who are public health nurses or who meet
5 the qualifications of public health nurses, as specified in section 250.06 (1) of the
6 statutes, or by social workers, as defined in section 252.15 (1) (er) of the statutes.

7 4. Conduct social marketing, including outreach, assuring health care access,
8 public awareness programs, community health education programs, and other best
9 practices and evidence-based practices, to reduce fetal and infant mortality and
10 morbidity.

11 5. Evaluate the quality and effectiveness of the services provided under
12 subdivisions 3. and 4.

13 (d) In 2008 and 2009, the city health department shall prepare a report on fetal
14 and infant mortality and morbidity in areas of the county that are encompassed by
15 the zip codes 53402 to 53406. The report shall be derived, at least in part, from a
16 multidisciplinary review of all fetal and infant deaths in the relevant year and shall
17 specify causation found for the mortality and morbidity. The city health department
18 shall submit the report to all of the following:

- 19 1. The city of Racine.
- 20 2. The department of health and family services.
- 21 3. The legislature, in the manner provided under section 13.172 (3) of the
22 statutes.
- 23 4. The governor.

24 (7j) MEDICAL ASSISTANCE PHARMACY DISPENSING FEE.

1 (a) In this subsection, "public assistance programs" means medical assistance,
2 as defined in section 49.43 (8) of the statutes, and the programs under sections 49.665
3 and 49.688 of the statutes, as affected by this act.

4 (b) The department of health and family services shall determine the amount
5 by which reimbursement to pharmacies for multisource generic drug products under
6 public assistance programs will be reduced as a result of implementation of average
7 manufacturing price reimbursement standards in accordance with the federal
8 Deficit Reduction Act of 2005, and shall determine the amount by which the
9 pharmacy dispensing fee under public assistance programs must be increased to
10 compensate for that reduction in reimbursement.

11 (c) The department of health and family services shall submit to the U.S.
12 department of health and human services an amendment to the state plan for
13 medical assistance that authorizes the department of health and family services to
14 increase the pharmacy dispensing fee under public assistance programs by the
15 amount determined under paragraph (b), and, if the U.S. department of health and
16 human services approves the amendment, shall increase the dispensing fee upon
17 approval.

18 (7k) REPORT ON FOOD STAMP EMPLOYMENT AND TRAINING PROGRAM PARTICIPATION.
19 The department of health and family services shall submit to the joint committee on
20 finance, no later than January 1, 2009, a report that compares participation in the
21 food stamp employment and training program after participation becomes voluntary
22 with participation in the program before participation became voluntary.

23 (7L) SMOKING CESSATION PROGRAM. The department of health and family
24 services shall create, and, by the first day of the 7th month beginning after the
25 effective date of this subsection, implement an incentive-based smoking cessation

1 program for medical assistance recipients. The program shall incorporate elements
2 of existing smoking cessation programs administered by the state. The emphasis of
3 the program shall be to have medical assistance recipients stop smoking as soon as
4 possible. The department of health and family services may enter into an agreement
5 with another person to create or administer the program.

6 (7p) REPORT ON PURCHASE OF DRUGS FOR HIV/AIDS.

7 (a) The department of health and family services shall determine the feasibility
8 of modifying the pilot program under section 49.686 (6) of the statutes, as created by
9 this act, in the following manner:

10 1. The cost of drugs for individuals in the pilot program and for which
11 reimbursement may be provided under section 49.686 (2) of the statutes would
12 continue to be paid for under the program under section 49.686 (1) to (5) of the
13 statutes.

14 2. The Health Insurance Risk-Sharing Plan would reimburse the program
15 under section 49.686 (1) to (5) of the statutes for the drug costs paid by that program
16 under subdivision 1.

17 (b) No later than January 1, 2008, the department shall submit a report with
18 its conclusions to the Joint Committee on Finance.

19 (8k) DENTAL ACCESS FUNDING. From the net savings projected to result from the
20 implementation of the BadgerCare Plus program under section 49.471 of the
21 statutes, as created by this act, the department of health and family services shall
22 provide \$200,000 in fiscal year 2007-08 to the Peter Christensen Health Center and
23 \$200,000 in fiscal year 2007-08 to the Lake Superior Community Health Center to
24 increase access to dental services under the related initiatives that are to be funded
25 from those projected net savings.

1 (8x) CLINIC GRANT FOR DENTAL SERVICES. From the appropriation under section
2 20.435 (5) (dm) of the statutes, as affected by this act, the department of health and
3 family services shall provide \$17,500 in fiscal year 2007-08 and \$17,500 in fiscal year
4 2008-09 to the Community Connections Free Clinic in Dodgeville to provide dental
5 services to low-income residents of Iowa County and surrounding areas.

6 (9f) STATE CENTERS FOR THE DEVELOPMENTALLY DISABLED. The authorized FTE
7 positions for the department of health and family services are increased by 6.64 PR
8 positions on July 1, 2007, to be funded from the appropriation account under section
9 20.435 (2) (gk) of the statutes, for the purpose of performing services at the state
10 centers for the developmentally disabled.

11 (9g) HOSPITAL ASSESSMENT REPORT. By December 31, 2008, and December 31,
12 2009, and December 31, 2010, the department of health and family services shall
13 report to the joint committee on finance of the legislature all of the following
14 information for the immediately previous state fiscal year:

15 (a) The total amount of assessments collected under section 50.375 of the
16 statutes, as created by this act.

17 (b) The total amount of assessments collected from each hospital under section
18 50.375 of the statutes, as created by this act.

19 (c) The total amounts that the department of health and family services
20 determines were paid under section 49.45 (58) of the statutes, as created by this act,
21 to health maintenance organizations as increased Medical Assistance payments to
22 hospitals.

23 (d) The total amount of periodic interim payments made to each hospital by
24 health maintenance organizations under section 49.45 (58) of the statutes, as created
25 by this act.

1 (e) The total amount of Medical Assistance payments made to each hospital and
2 the portion of the Medical Assistance capitated payments made to health
3 maintenance organizations for inpatient and outpatient hospital services from
4 appropriation accounts of general purpose revenues.

5 (f) The total amounts obtained under paragraphs (c) and (e).

6 (g) The results of any audits conducted by the department of health and family
7 services under section 49.45 (58) of the statutes, as created by this act, concerning
8 Medical Assistance payments and any actions taken by the department as a result
9 of such an audit.

10 (9h) STATE PLAN AMENDMENT REQUEST. The department of health and family
11 services shall submit to the Centers for Medicare and Medicaid Services a request
12 to amend the Medical Assistance state plan that is in effect on July 1, 2009, in order
13 to use the Medical Assistance reimbursement methodology for payment to hospitals
14 that was used prior to use of the Medical Assistance reimbursement methodology
15 used during implementation of the assessment under section 50.375 of the statutes,
16 as created by this act.

17 (9i) TRANSFER AND RENAMING OF COUNCIL ON DEVELOPMENTAL DISABILITIES.

18 (a) *Assets and liabilities.* On the effective date of this paragraph, the assets and
19 liabilities of the department of health and family services primarily related to the
20 council on developmental disabilities, as determined by the secretary of
21 administration, shall become the assets and liabilities of the board for people with
22 developmental disabilities.

23 (b) *Employee transfers.* All incumbent employees holding positions in the
24 department of health and family services performing duties primarily related to the
25 functions of the council on developmental disabilities, as determined by the secretary

by this act

1 of administration, are transferred on the effective date of this paragraph to the board
2 for people with developmental disabilities.

3 (c) *Employee status.* Employees transferred under paragraph (b) have all the
4 rights and the same status under subchapter V of chapter 111 and under chapter 230
5 of the statutes in the board for people with developmental disabilities that they
6 enjoyed in the department of health and family services immediately before the
7 transfer. Notwithstanding section 230.28 (4) of the statutes, no employee so
8 transferred who has attained permanent status in class is required to serve a
9 probationary period.

10 (d) *Tangible personal property.* On the effective date of this paragraph, all
11 tangible personal property, including records, of the department of health and family
12 services that is primarily related to the functions of the council on developmental
13 disabilities, as determined by the secretary of administration, is transferred to the
14 board for people with developmental disabilities.

15 (e) *Contracts.* All contracts entered into by the department of health and family
16 services in effect on the effective date of this paragraph that are primarily related
17 to the functions of the council on developmental disabilities, as determined by the
18 secretary of administration, remain in effect and are transferred to the board for
19 people with developmental disabilities. The board for people with developmental
20 disabilities shall carry out any obligations under such a contract until the contract
21 is modified or rescinded by the board to the extent allowed under the contract.

22 (em) *Pending matters.* Any matter pending with the department of health and
23 family services on the effective date of this paragraph that is primarily related to the
24 council on developmental disabilities, as determined by the secretary of
25 administration, is transferred to the board for people with developmental disabilities

1 and all materials submitted to or actions taken by the department of health and
2 family services with respect to the pending matter are considered as having been
3 submitted to or taken by the board.

4 (9p) GRANT FOR HIV INFECTION SERVICES. From the appropriation account under
5 section 20.435 (5) (ma) of the statutes, as affected by this act, the department of
6 health and family services shall provide to the Black Health Coalition of Wisconsin,
7 Inc., \$100,000 in state fiscal year 2007-08 as a one-time grant to provide HIV
8 infection outreach, education, referral, and other services.

9 (9u) DANE COUNTY EARLY CHILDHOOD INITIATIVES. From the appropriation
10 account under section 20.435 (3) (bc) of the statutes, as affected by section 341x of this
11 act, the department of health and family services shall distribute \$250,000 in fiscal
12 year 2007-08 for comprehensive early childhood initiatives in Dane County that
13 provide home visiting and employment preparation and support for low-income
14 families.

17 (1) WISCONSIN COVENANT SCHOLARS PROGRAM.

18 (a) *Rules.* The higher educational aids board shall submit in proposed form the
19 rules required under section 39.437 (5) of the statutes, as created by this act, to the
20 legislative council staff under section 227.15 (1) of the statutes no later than the first
21 day of the 18th month beginning after the effective date of this paragraph.

22 (b) *Emergency rules.* Using the procedure under section 227.24 of the statutes,
23 ~~the higher educational aids board may promulgate the rules required under section~~
24 39.437 (5) of the statutes, as created by this act, for the period before the effective date
25 of the permanent rules submitted under paragraph (a), but not to exceed the period

1 authorized under section 227.24 (1) (c) and (2) of the statutes. Notwithstanding
2 section 227.24 (1) (a), (2) (b), and (3) of the statutes, the higher educational aids board
3 is not required to provide evidence that promulgating a rule under this paragraph

5 safety, or welfare and is not required to provide a finding of emergency for a rule
6 promulgated under this paragraph.

12 (1f) OPERATING EXPENDITURES. Notwithstanding section 25.187 (2) (c) 1. of the
13 statutes, as affected by this act, the total amount that the investment board may
14 assess the funds for which the board has management responsibility during the
15 2007-08 fiscal year may not exceed the greater of the amount that the board could
16 have assessed the funds during the 2006-07 fiscal year or 0.0285 percent of the
17 average market value of the assets of the funds at the end of each month between
18 November 30 and April 30 of the 2006-07 fiscal year.

19 (1h) INITIATIVES REPORTS.

20 (a) During the 2008-09 fiscal year, on or before January 31, 2009, the
21 investment board shall submit a report to the joint legislative audit committee and
22 the joint committee on finance on the implementation and outcomes of initiatives
23 commenced as a result of the changes in expenditure authority under section 25.187
24 (2) (c) 1. of the statutes, as affected by this act.

1 (b) During the 2009-10 fiscal year, on or before January 31, 2010, the
2 investment board shall submit a report to the joint legislative audit committee and
3 the joint committee on finance on the implementation and outcomes of initiatives
4 commenced as a result of the changes in expenditure authority under section 25.187
5 (2) (c) 1. of the statutes, as affected by this act.

9 (1f) DISTRICT ATTORNEY POSITION; ST. CROIX COUNTY. From the appropriation
10 account under section 20.455 (2) (n) of the statutes, the department of justice shall
11 expend \$32,400 in fiscal year 2007-08 and \$64,800 in fiscal year 2008-09 to provide
12 1.0 assistant district attorney position in St. Croix County.

13 (1h) DISTRICT ATTORNEY POSITION; CHIPPEWA COUNTY. From the appropriation
14 account under section 20.455 (2) (n) of the statutes, the department of justice shall
15 expend \$16,700 in fiscal year 2007-08 and \$16,700 in fiscal year 2008-09 to provide
16 .25 assistant district attorney position in Chippewa County.

17 **SECTION 9130. Nonstatutory provisions; Legislature.**

18 (1d) JOINT SURVEY COMMITTEE ON RETIREMENT SYSTEMS; ACTUARIAL OPINION OF 2007
19 SENATE BILL 19 OR 2007 ASSEMBLY BILL 43. The cochairpersons of the joint survey
20 committee on retirement systems, pursuant to the powers granted the
21 cochairpersons under section 13.50 (6) (am) of the statutes, are requested to order,
22 during the 2007-08 fiscal year, an actuarial opinion on the impact of 2007 Senate Bill
23 19 or 2007 Assembly Bill 43, and any pending amendments, on the costs, actuarial
24 balance, or goals of the Wisconsin Retirement System.

25 (1f) ELIMINATION OF REVISOR OF STATUTES BUREAU.

1 (a) On December 31, 2007, all assets and liabilities of the revisor of statutes
2 bureau shall become the assets and liabilities of the legislative reference bureau.

3 (b) On December 31, 2007, all tangible personal property, including records, of
4 the revisor of statutes bureau is transferred to the legislative reference bureau.

5 (c) On December 31, 2007, all contracts entered into by the revisor of statutes
6 bureau, which are in effect on December 31, 2007, remain in effect and are
7 transferred to the legislative reference bureau. The legislative reference bureau
8 shall carry out any such contractual obligations until modified or rescinded by the
9 legislative reference bureau to the extent allowed under the contract.

10 (d) 1. If requested by any person who holds an attorney position at the revisor
11 of statutes bureau, the chief of the legislative reference bureau shall interview the
12 person to fill an attorney position at the legislative reference bureau. The chief of
13 the legislative reference bureau shall offer employment at the legislative reference
14 bureau, beginning on or before December 31, 2007, to one person who holds an
15 attorney position at the revisor of statutes bureau.

16 2. If requested by any person who holds a publications editor position at the
17 revisor of statutes bureau, the chief of the legislative reference bureau shall
18 interview the person to fill a publications editor position at the legislative reference
19 bureau. The chief of the legislative reference bureau shall offer employment at the
20 legislative reference bureau, beginning on or before December 31, 2007, to one
21 person who holds a publications editor position at the revisor of statutes bureau.

23 (a) *Advisory role of special committee on strengthening Wisconsin's families.*
