

Hi all- After going through the special session bill, Daryl and I found the following errors:

Section 644d. (page 417 lines 10 and 12). This section refers to the property development and local assistance subprogram of stewardship. Line 10 should read: "2002-03 and ending with fiscal year 2009-10", and line 12 should read "each fiscal year beginning with 2010-11 and ending with fiscal year 2019-20".

The \$26 million a year dedicated to this subprogram should not begin until 2010-11 (the bill draft has this amount beginning in 2007-08).

Also, we wanted to mention again that the chapter 20 schedule did not pick up the transfer of \$1.5 million in 2007-08 and \$2.5 million in 2008-09 from the recreational boating aids appropriation (5cq) to the aquatic invasive species grants appropriation (6as). There was also one other chapter 20 schedule correction that I believe I mentioned to Jana yesterday: the amounts in the schedule for the wildlife damage appropriation (5fq) should be \$15 million less in each year, and the amounts in the schedule for the venison processing, voluntary contributions, should be \$15 million in each year instead of zero.


