9 5.05 (1) GENERAL AUTHORITY. (intro.) The elections government accountability
10 board shall have the responsibility for the administration of chs. 5 to 12 and, other
11 laws relating to elections and election campaigns, subch. III of ch. 13, and subch. III
12 of ch. 19. Pursuant to such responsibility, the board may:

13 **SECTION 4.** 5.05 (1) (a) of the statutes is repealed.

14 **SECTION 5.** 5.05 (1) (b) of the statutes is amended to read:

15 5.05 (1) (b) In the discharge of its duties and ~~upon~~ after providing notice to the
16 any party or parties being investigated who is the subject of an investigation,
17 subpoena and bring before it any person ~~in the state~~ and require the production of
18 any papers, books, or other records relevant to an investigation. Notwithstanding
19 s. 885.01 (4), the issuance of a subpoena requires action by the board at a meeting
20 of the board. A circuit court may by order permit the inspection and copying of the
21 accounts and the depositor’s and loan records at any financial institution, as defined

1 in s. 705.01 (3), doing business in the state to obtain evidence of any violation of ch.
2 11 upon showing by the board of probable cause to believe there is a violation and that
3 such accounts and records may have a substantial relation to the violation. In the
4 discharge of its duties, the board may cause the deposition of witnesses to be taken
5 in the manner prescribed for taking depositions in civil actions in circuit court.

11 chs. 5 to 12, subch. III of ch. 13, or subch. III of ch. 19 or a license revocation for any
12 violation of subch. III of ch. 13 for which the offender is subject to a revocation. The
13 board may compromise and settle any civil action or potential action brought or
14 authorized to be brought by it ~~under ch.11~~ which, in the opinion of the board,
15 constitutes a minor violation, a violation caused by excusable neglect, or which for
16 other good cause shown, should not in the public interest be prosecuted under such

18 authorized under this paragraph may be settled for such sum as may be agreed
19 between the parties. Any settlement made by the board shall be in such amount as
20 to deprive the alleged violator of any benefit of his or her wrongdoing and may

22 civil actions or proposed civil actions, the board shall treat comparable situations in
23 a comparable manner and shall assure that any settlement bears a reasonable
24 relationship to the severity of the offense or alleged offense. ~~Forfeiture~~ Except as

1 (8), forfeiture and license revocation actions brought by the board shall be brought
2 in the circuit court for the county where the defendant resides, or if the defendant
3 is a nonresident of this state, in circuit court for the county wherein the violation is
4 alleged to occur. For purposes of this paragraph, a person other than a natural
5 person resides within a county if the person's principal place of operation is located
6 within that county. Whenever the board enters into a settlement agreement with an
7 individual who is accused of a civil violation of chs. 5 to 12, subch. III of ch. 13, or
8 subch. III of ch. 19 or who is investigated by the board for a possible civil violation
9 of one of those provisions, the board shall reduce the agreement to writing, together
10 with a statement of the board's findings and reasons for entering into the agreement
11 and shall retain the agreement and statement in its office for inspection.

23 5.05 **(1e)** ACTIONS BY THE BOARD. Any action by the board requires the
24 affirmative vote of at least 4 members.

25 **SECTION 9.** 5.05 (1m) of the statutes is created to read:

1 **5.05 (1m) LEGAL COUNSEL.** The board shall employ outside the classified service
2 an individual to serve as legal counsel who shall perform legal and administrative
3 functions for the board.

4 **SECTION 10.** 5.05 (2m), (2s) and (2w) of the statutes are created to read:

5 **5.05 (2m) ENFORCEMENT.** (a) The board shall investigate violations of laws
6 administered by the board and may prosecute alleged civil violations of those laws,
7 directly or through its agents under this subsection, pursuant to all statutes granting
8 or assigning that authority or responsibility to the board. Prosecution of alleged
9 criminal violations investigated by the board may be brought only as provided in par.
10 (c) 11., 14., 15., and 16. and s. 978.05 (1).

11 (c) 2. a. Any person may file a complaint with the board alleging a violation of
12 chs. 5 to 12, subch. III of ch. 13, or subch. III of ch. 19. If the board finds, by a
13 preponderance of the evidence, that a complaint is frivolous, the board may order the
14 complainant to forfeit not more than the greater of \$500 or the expenses incurred by
15 the division in investigating the complaint.

16 4. If the board reviews a complaint and fails to find that there is a reasonable
17 suspicion that a violation under subd. 2. has occurred or is occurring, the board shall
18 dismiss the complaint. If the board believes that there is reasonable suspicion that
19 a violation under subd. 2. has occurred or is occurring, the board may by resolution
20 authorize the commencement of an investigation. The resolution shall specifically
21 set forth any matter that is authorized to be investigated. To assist in the
22 investigation, the board may elect to retain a special investigator. If the board elects
23 to retain a special investigator, the administrator of the ethics and accountability
24 division shall submit to the board the names of 3 qualified individuals to serve as a
25 special investigator. The board may retain one or more of the individuals. If the

1 board retains a special investigator to investigate a complaint against a person who
2 is a resident of this state, the board shall provide to the district attorney for the
3 county in which the person resides a copy of the complaint and shall notify the
4 district attorney that it has retained a special investigator to investigate the
5 complaint. For purposes of this subdivision, a person other than a natural person
6 resides within a county if the person's principal place of operation is located within
7 that county. The board shall enter into a written contract with any individual who
8 is retained as a special investigator setting forth the terms of the engagement. A
9 special investigator who is retained by the board may request the board to issue a
10 subpoena to a specific person or to authorize the special investigator to request a
11 circuit court to issue a search warrant. The board may grant the request by
12 approving a motion to that effect at a meeting of the board if the board finds that such
13 action is legally appropriate.

14 5. Each special investigator who is retained by the board shall make periodic
15 reports to the board, as directed by the board, but in no case may the interval for
16 reporting exceed 30 days. If the board authorizes the administrator of the ethics and
17 accountability division to investigate any matter without retaining a special
18 investigator, the administrator shall make periodic reports to the board, as directed
19 by the board, but in no case may the reporting interval exceed 30 days. During the
20 pendency of any investigation, the board shall meet for the purpose of reviewing the
21 progress of the investigation at least once every 90 days. The special investigator or
22 the administrator shall report in person to the board at that meeting concerning the
23 progress of the investigation. If, after receiving a report, the board does not vote to
24 continue an investigation for an additional period not exceeding 90 days, the
25 investigation is terminated at the end of the reporting interval. The board shall not

1 expend more than \$10,000 to finance the cost of an investigation before receiving a
2 report on the progress of the investigation and a recommendation to commit
3 additional resources. The board may vote to terminate an investigation at any time.
4 If an investigation is terminated, any complaint from which the investigation arose
5 is deemed to be dismissed by the board. Unless an investigation is terminated by the
6 board, at the conclusion of each investigation, the administrator shall present to the
7 board one of the following:

8 a. A recommendation to make a finding that probable cause exists to believe
9 that one or more violations under subd. 2. have occurred or are occurring, together
10 with a recommended course of action.

11 b. A recommendation for further investigation of the matter together with facts
12 supporting that course of action.

13 c. A recommendation to terminate the investigation due to lack of sufficient
14 evidence to indicate that a violation under subd. 2 has occurred or is occurring.

15 6. a. If the board finds that there is probable cause to believe that a violation
16 under subd. 2. has occurred or is occurring, the board may authorize the
17 administrator of the ethics and accountability division to file a civil complaint
18 against the alleged violator. In such case, the administrator may request the
19 assistance of special counsel to prosecute any action brought by the board. If the
20 administrator requests the assistance of special counsel with respect to any matter,
21 the administrator shall submit to the board the names of 3 qualified individuals to
22 serve as special counsel. The board may retain one of the individuals to act as special
23 counsel. The staff of the board shall provide assistance to the special counsel as may
24 be required by the counsel to carry out his or her responsibilities.

1 b. The board shall enter into a written contract with any individual who is
2 retained as special counsel setting forth the terms of the engagement. The contract
3 shall set forth the compensation to be paid such counsel by the state. The contract
4 shall be executed on behalf of the state by the board's legal counsel, who shall file the
5 contract in the office of the secretary of state. The compensation shall be charged to
6 the appropriation under s. 20.455 (1) (b).

7 7. No individual who is appointed or retained by the board to serve as special
8 counsel or as a special investigator is subject to approval under s. 20.930.

9 8. Upon employment of any individual to serve as special counsel or as a special
10 investigator for the board, the administrator of the ethics and accountability division
11 shall certify the maximum amount provided in the employment contract to the
12 secretary of administration, and direct the department of administration to pay bills
13 of the special counsel or special investigator related to that case within the certified
14 amount.

15 11. If the board finds that there is probable cause to believe that a violation
16 under subd. 2. has occurred or is occurring, the board may, in lieu of civil prosecution
17 of any matter by the board, refer the matter to the district attorney for the county
18 in which the alleged violator resides, or if the alleged violator is a nonresident, to the
19 district attorney for the county where the matter arises, or if par. (i) applies, to the
20 attorney general or a special prosecutor. For purposes of this subdivision, a person
21 other than a natural person resides within a county if the person's principal place of
22 operation is located within that county.

23 12. The board may, by rule, prescribe categories of civil offenses which the board
24 will agree to compromise and settle without a formal investigation upon payment of
25 specified amounts by the alleged offender. The board may authorize the

1 administrator of the ethics and accountability division to compromise and settle such
2 alleged offenses in the name of the board if the alleged offenses by an offender, in the
3 aggregate, do not involve payment of more than \$1,000.

4 13. If a special investigator or the administrator of the ethics and
5 accountability division, in the course of an investigation authorized by the board,
6 discovers evidence that a violation under subd. 2. that was not within the scope of
7 the authorized investigation has occurred or is occurring, the special investigator or
8 the administrator may present that evidence to the board. If the board finds that
9 there is a reasonable suspicion that a violation under subd. 2. that is not within the
10 scope of the authorized investigation has occurred or is occurring, the board may
11 authorize the special investigator or the administrator to investigate the alleged
12 violation or may elect to authorize a separate investigation of the alleged violation
13 as provided in subd. 4.

14 14. If a special investigator or the administrator of the ethics and
15 accountability division of the board, in the course of an investigation authorized by
16 the board, discovers evidence of a potential violation of a law that is not administered
17 by the board arising from or in relation to the official functions of the subject of the
18 investigation or any matter that involves elections, ethics, or lobbying regulation,
19 the special investigator or the administrator may present that evidence to the board.
20 The board may thereupon refer the matter to the appropriate district attorney
21 specified in subd. 11.

22 15. Except as provided in subd. 17., if the board refers a matter to the district
23 attorney specified in subd. 11. for prosecution of a potential violation under subd. 2.
24 or 14. and the district attorney informs the board that he or she declines to prosecute
25 any alleged civil or criminal violation related to any matter referred to the district

1 attorney by the board, or the district attorney fails to commence a prosecution of any
2 civil or criminal violation related to any matter referred to the district attorney by
3 the board within 60 days of the date of the board's referral, the board may refer the
4 matter to the district attorney for another prosecutorial unit that is contiguous to the
5 prosecutorial unit of the district attorney to whom the matter was originally
6 referred. If there is more than one such prosecutorial unit, the chairperson of the
7 board shall determine the district attorney to whom the matter shall be referred by
8 publicly drawing lots at a meeting of the board. The district attorney may then
9 commence a civil or criminal prosecution relating to the matter.

10 16. Except as provided in subd. 17., if the board refers a matter to a district
11 attorney under subd. 15. for prosecution of a potential violation under subd. 2. or 14.
12 and the district attorney informs the board that he or she declines to prosecute any
13 alleged civil or criminal violation related to any matter referred to the district
14 attorney by the board, or the district attorney fails to commence a prosecution of any
15 civil or criminal violation related to any matter referred to the district attorney by
16 the board within 60 days of the date of the board's referral, the board may refer the
17 matter to the attorney general. The attorney general may then commence a civil or
18 criminal prosecution relating to the matter.

19 17. The board is not authorized to act under subd. 15. or 16. if a special
20 prosecutor is appointed under s. 978.045 in lieu of the district attorney specified in
21 subd. 11.

22 18. Whenever the board refers a matter to special counsel or to a district
23 attorney or to the attorney general under this subsection, the special counsel, district
24 attorney, or attorney general shall report to the board concerning any action taken
25 regarding the matter. The report shall be transmitted no later than 40 days after the

1 date of the referral. If the matter is not disposed of during that period, the special
2 counsel, district attorney, or attorney general shall file a subsequent report at the
3 end of each 30–day period following the filing of the initial report until final
4 disposition of the matter.

5 (d) 1. No individual who serves as the legal counsel to the board or as a division
6 administrator for the board may have been a lobbyist, as defined in s. 13.62 (11). No
7 such individual may have served in, or have been a candidate, as defined in s. 11.01
8 (1), for, a partisan state or local office.

9 2. No employee of the board, while so employed, may become a candidate, as
10 defined in s. 11.01 (1), for a state or partisan local office. No individual who is
11 retained by the board to serve as a special investigator or as special counsel may,
12 while so retained become a candidate, as defined in s. 11.01 (1), for any state or local
13 office. A filing officer shall decline to accept nomination papers or a declaration of
14 candidacy from any individual who does not qualify to become a candidate under this
15 paragraph.

16 (e) No individual who serves as an employee of the board and no individual who
17 is retained by the board to serve as a special investigator or a special counsel may,
18 while so employed or retained, make a contribution, as defined in s. 11.01 (6), to a
19 candidate for state or local office. No individual who serves as an employee of the
20 board and no individual who is retained by the board to serve as a special investigator
21 or as special counsel, for 12 months prior to becoming so employed or retained, may
22 have made a contribution, as defined in s. 11.01 (6), to a candidate for a partisan state
23 or local office.

24 (h) If the defendant in an action for a civil violation of chs. 5 to 12, subch. III
25 of ch. 13, or subch. III of ch. 19 is a district attorney or a circuit judge or a candidate

1 for either such office, the action shall be brought by the board. If the defendant in
2 an action for a civil violation of chs. 5 to 12, subch. III of ch. 13, or subch. III of ch.
3 19 is the attorney general or a candidate for that office, the board may appoint special
4 counsel to bring suit on behalf of the state.

5 (i) If the defendant in an action for a criminal violation of chs. 5 to 12, subch.
6 III of ch. 13, or subch. III of ch. 19 is a district attorney or a circuit judge or a candidate
7 for either such office, the action shall be brought by the attorney general. If the
8 defendant in an action for a criminal violation of chs. 5 to 12, subch. III of ch. 13, or
9 subch. III of ch. 19 is the attorney general or a candidate for that office, the board may
10 appoint a special prosecutor to conduct the prosecution on behalf of the state.

11 (j) Any special counsel or prosecutor who is appointed under par. (h) or (i) shall
12 be independent of the attorney general and need not be a state employee at the time
13 of his or her appointment.

14 **(2s)** ETHICS AND ACCOUNTABILITY DIVISION. The ethics and accountability
15 division has the responsibility for administration of ch. 11, subch. III of ch. 13, and
16 subch. III of ch. 19.

17 **(2w)** ELECTIONS DIVISION. The elections division has the responsibility for the
18 administration of chs. 5 to 10 and 12.

19 **SECTION 11.** 5.05 (3) of the statutes is repealed.

20 **SECTION 12.** 5.05 (3g) of the statutes is created to read:

21 5.05 **(3g)** CHIEF ELECTION OFFICER. The board shall designate an employee of
22 the board to serve as the chief election officer of this state.

3 (d) If the board commences a civil prosecution of a person for an alleged
4 violation of chs. 5 to 12, subch. III of ch. 13, or subch. III of ch. 19 as the result of an
5 investigation, the person who is the subject of the investigation may authorize the
6 board to make available for inspection and copying under s. 19.35 (1) records of the
7 investigation pertaining to that person if the records are available by law to the
8 subject person and the board shall then make those records available.

9 (e) The following records of the board are open to public inspection and copying
10 under s. 19.35 (1):

11 1. Any record of the action of the board authorizing the filing of a civil complaint
12 under sub. (2m) (c) 6.

13 2. Any record of the action of the board referring a matter to a district attorney
14 or other prosecutor for investigation or prosecution.

15 3. Any record containing a finding that a complaint does not raise a reasonable
16 suspicion that a violation of the law has occurred.

17 4. Any record containing a finding, following an investigation, that no probable
18 cause exists to believe that a violation of the law has occurred.

19 **SECTION 16.** 5.05 (5s) (f) 2. c. of the statutes is created to read:

20 5.05 **(5s)** (f) 2. c. The board shall make public advisory opinions and records
21 obtained in connection with requests for advisory opinions relating to matters under
22 the jurisdiction of the elections division.

1 5.05 **(9)** **STANDING.** The board has standing to commence or intervene in an any

8 order by more than 6 months in all.

9 (f) *Formal opinions.* Within one year after the initiation date, the board shall
10 hold one or more public hearings on the question of reaffirmation of each formal
11 opinion that has been issued by the ethics board and that has not been withdrawn
12 or modified. If the formal opinion is confidential, the board shall hold the hearing
13 on the question of reaffirmation of the summary of the opinion that has been
14 published. Except as authorized in this paragraph, every formal opinion issued by
15 the ethics board or by the executive director of the ethics board acting in its stead that
16 has not been withdrawn or modified on the initiation date remains in effect until the
17 end of the 365–day period beginning on the initiation date unless that board
18 withdraws or modifies the opinion on an earlier date, or unless that board specifically
19 votes to reaffirm the opinion on an earlier date. The board may extend the period
20 of effectiveness of any formal opinion under this paragraph for not more than 3
21 months in order to afford time for additional review, but no such extension or renewal
22 of an extension may extend the period of effectiveness of an opinion by more than 6
23 months in all.

24 (g) *Review of guidelines.* Within one year after the initiation date, the board
25 shall hold one or more public hearings for the purpose of reviewing the question of

1 reaffirmation of each current guideline that has been issued by the ethics board. The
2 review shall address the extent to which the guidelines are consistent with relevant
3 law. Except as authorized in this paragraph, the government accountability board
4 shall withdraw each guideline identified in this paragraph at the end of the 365–day
5 period beginning on the initiation date, unless the board chooses to withdraw or
6 revise the guideline at an earlier date or unless the board specifically votes to
7 reaffirm the current text of the guideline as issued prior to the end of that period.
8 The board may extend the circulation period of any guideline identified in this
9 paragraph for not more than 3 months in order to afford time for additional review,
10 but no such extension or renewal of an extension may extend the circulation period
11 of a guideline by more than 6 months in all.

12 (h) *Review of internal operating procedures.* During the 365–day period
13 beginning on the initiation date, the board shall review all internal operating
14 procedures of the ethics board in effect on the initiation date that affect the manner
15 in which the board interrelates with persons who are not employees of the board. The
16 review shall specifically address the degree to which employees are authorized to
17 perform their functions without direct supervision of or approval of the board.
18 During the pendency of the review, no employee of the government accountability
19 board may make any change in an internal operating procedure described in this
20 paragraph unless that board first holds a public hearing concerning the proposed
21 change and that board specifically approves the change.

22 (i) *Pending matters.* Any matter pending with the ethics board on the effective
23 date of this paragraph is transferred to the government accountability board, and all
24 materials submitted to or actions taken by the ethics board with respect to the

1 pending matter are considered as having been submitted to or taken by the
2 government accountability board.

3 (4) CONFIRMATION OF PERSONS NOMINATED TO INITIALLY FILL POSITIONS ON THE
4 BOARD. Notwithstanding section 15.07 (1) (a) 2. of the statutes, as affected by this act,
5 the governor shall submit the names of the nominees to initially fill 3 of the positions
6 as members of the government accountability board to the assembly and shall
7 submit the names of the nominees to initially fill 3 of the positions as members of the
8 government accountability board to the senate, and the nominees to initially fill
9 those positions are subject to confirmation solely by a majority of the members
10 present and voting on a nomination in the house to which their names are submitted.
11 Notwithstanding section 5.052 (4) of the statutes, as created by this act, if a nominee
12 of the governor to initially fill a position as a member of the government
13 accountability board dies or withdraws, or if such a nomination is withdrawn by the
14 governor or rejected by the house to which submitted under this subsection, the
15 government accountability candidate committee shall submit an additional nominee
16 to the governor for appointment to the board, subject to confirmation by the same
17 house in accordance with this subsection.

18 (5) BOARD TRANSITIONS; INITIAL TERMS.

19 (a) Notwithstanding section 15.61, 2005 stats., section 15.62, 2005 stats., and
20 section 15.07 (1) (c) of the statutes, the terms of office of all members of the elections
21 board and all members of the ethics board holding office shall expire on the initiation
22 date.

23 (b) Each member of the government accountability board who is appointed as
24 provided in paragraph (c) and qualified to take office shall take office on the effective
25 date of this paragraph, or upon qualification to take office, whichever is later.

1 Notwithstanding section 15.07 (4) of the statutes, as affected by this act, the board
2 does not have a quorum for transaction of business at its initial meeting until 6
3 members have initially been appointed and qualify to serve.

4 (c) The government accountability candidate committee shall submit to the
5 governor the names of at least 8 qualified individuals to fill the initial positions as
6 members of the government accountability board. In making nominations to
7 initially fill positions as members of the government accountability board, the
8 government accountability candidate committee shall draw lots at a meeting of the
9 committee to assign a numerical sequence to each nomination, beginning with the
10 number one. Notwithstanding section 15.60 (1) of the statutes, as created by this act,
11 from the nominations submitted, the governor shall nominate the nominee who is
12 assigned the lowest number to serve for a term expiring on May 1, 2014; the nominee
13 having the next highest number to serve for a term expiring on May 1, 2013; the
14 nominee having the next highest number to serve for a term expiring on May 1, 2012;
15 the nominee having the next highest number to serve for a term expiring on May 1,
16 2011; the nominee having the next highest number to serve for a term expiring on
17 May 1, 2010; and the nominee having the next highest number to serve for a term
18 expiring on May 1, 2009.

19 (d) Notwithstanding section 15.60 (2) of the statutes, as created by this act, the
20 initial members of the governmental accountability candidate committee shall serve
21 for terms expiring on March 1, 2009.

22 (6) IMPLEMENTATION.

23 (a) Notwithstanding section 5.05 (1m) and (2m) of the statutes, as created by
24 this act, and section 20.922 (1) of the statutes, the director of the legislative council
25 staff shall provide such administrative support to the government accountability

1 board as the board may require, without additional compensation for such service,
2 until such time as the board initially appoints a legal counsel to the board and the
3 appointee takes office. The director of the legislative council staff is vested with full
4 authority and responsibility to carry out all administrative functions of the legal
5 counsel to the government accountability board, the divisions in the government
6 accountability board, and the administrators of the divisions prior to appointment
7 and qualification of the initial legal counsel, including the retention and termination
8 of all staff not transferred to the board that the board is authorized to employ under
9 this act.

10 (b) Notwithstanding section 15.07 (2) (b) of the statutes, as created by this act,
11 the member of the government accountability board who is first nominated shall
12 choose the initial chairperson of the board at the first meeting of the board in
13 accordance with section 15.07 (2) (b) of the statutes, as created by this act.

14 (c) Prior to the initiation date, the government accountability board may
15 expend moneys from the appropriation under section 20.511 (1) (a) of the statutes,
16 as created by this act, for the purpose of meeting, employing staff, and preparing to
17 assume its full authority and responsibilities on that date.

18 (7) JOINT COMMITTEE ON FINANCE. Of the moneys appropriated to the joint
19 committee on finance under section 20.865 (4) (a) of the statutes for the 2005–07
20 fiscal biennium, \$155,400 is reserved to supplement the appropriation of the
21 government accountability board under section 20.511 (1) (a) of the statutes, as
22 created by this act, in fiscal year 2006–07 for the purposes described in SECTION 210
23 (5) of this act.

24 **SECTION 210. Fiscal changes.**

1 (1) The unencumbered balance in the appropriation account under section
2 20.510 (1) (h) of the statutes is transferred to the appropriation account under section
3 20.511 (1) (h) of the statutes, as created by this act.

4 (2) The unencumbered balance in the appropriation account under section
5 20.510 (1) (i) of the statutes is transferred to the appropriation account under section
6 20.511 (1) (i) of the statutes, as created by this act.

7 (3) The unencumbered balance in the appropriation account under section
8 20.521 (1) (g) of the statutes is transferred to the appropriation account under section
9 20.511 (1) (i) of the statutes, as created by this act.

10 (4) The unencumbered balance in the appropriation account under section
11 20.521 (1) (i) of the statutes is transferred to the appropriation account under section
12 20.511 (1) (h) of the statutes, as created by this act.

13 (5) In the schedule under section 20.005 (3) of the statutes for the appropriation
14 to the joint committee on finance under section 20.865 (4) (a) of the statutes, as
15 affected by the acts of 2005 and 2007, the dollar amount is increased by \$155,400 for
16 fiscal year 2006–07 to provide funding for the government accountability board to
17 hold meetings, employ staff, and prepare to assume its full authority and
18 responsibilities under this act.

19 **SECTION 211. Effective dates.** This act takes effect on the initiation date
20 specified in section 209 (1), except as follows:

21 (1) The treatment of sections 5.052, 5.054, 15.07 (1) (a) 2., (2) (b), and (5) (m),
22 15.60, 15.603, 20.511 (intro.) and (1) (title) and (a), 20.923 (4) (f) 3j., and 230.08 (2)
23 (e) 4h. and (on) and (4) (a) of the statutes, SECTIONS 209 (5) to (7) and 210 (5) of this
24 act take effect on the day after publication.
