

2007 ASSEMBLY BILL 270

April 13, 2007 – Introduced by Representatives MUSSER, TURNER, TOWNSEND, HAHN, HILGENBERG, A. OTT, HINES, ALBERS, CULLEN, GUNDERSON, VRUWINK, MURSAU, NEWCOMER and SHERIDAN, cosponsored by Senators SULLIVAN, ROESSLER, COWLES, RISSER, LEHMAN, LASSA, BRESKE, DARLING and SCHULTZ. Referred to Committee on Veterans and Military Affairs.

1 **AN ACT** *to amend* 15.497 (2) (a); and *to create* 15.497 (2) (e) and 15.497 (2) (f)
 2 of the statutes; **relating to:** changing the members of the Council on Veterans
 3 Programs.

Analysis by the Legislative Reference Bureau

Under current law the Council on Veterans Programs (council) advises the Board of Veterans Affairs and the Department of Veterans Affairs (DVA) on solutions and policy alternatives relating to the problems of veterans. The council is attached to DVA and consists of members of various veterans organizations, all of whom are appointed for one-year terms.

This bill adds one representative of each of the following to the council:

1. The Wisconsin Council of the Military Officers Association of America.
2. The Retired Enlisted Association.

This bill removes the representative of each of the following from the council:

1. The Veterans of World War I of the U.S.A., Inc.
 2. The Federation of Minority Veterans, Inc.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

4 **SECTION 1.** 15.497 (2) (a) of the statutes is amended to read:

11 ~~Federation of Minority Veterans, Inc.,~~ the Wisconsin Vietnam Veterans, Inc., and the
12 Military Order of the Purple Heart.

13 **SECTION 2.** 15.497 (2) (e) of the statutes is created to read:

16 **SECTION 3.** 15.497 (2) (f) of the statutes is created to read:

17 15.497 (2) (f) One representative of The Retired Enlisted Association.

18 **SECTION 4. Nonstatutory provisions.**

19 (1) Notwithstanding section 15.497 (2) (intro.), the term of the initial
20 representative of the Wisconsin Council of the Military Officers Association of
21 America and The Retired Enlisted Association on the council on veterans programs
22 shall expire on July 1, 2008.

23 **SECTION 5. Effective date.**
