TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO 2007 ASSEMBLY BILL 207

1 At the locations indicated, amend the substitute amendment as follows:

2 1. Page 25, line 21: delete the material beginning with that line and ending
3 with page 26, line 4 and substitute:

4 "(10m) RATE REGULATION. The public service commission shall promulgate
5 rules establishing requirements and procedures for the public service commission to
6 approve rates of video service providers for video service. The rules shall require the
7 public service commission to approve rates that the commission finds are reasonable
8 and in the public interest."

9 2. Page 37, line 12: after "(4)" insert "or its activities under the rules
10 promulgated under s. 66.0420 (10m)".
