ASSEMBLY AMENDMENT,  
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,  
TO 2007 ASSEMBLY BILL 207

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 15, line 8: after that line insert:

3 **“(4m) RATE DISCOUNTS.** An interim cable operator or a video service provider  
4 shall give a 10 percent discount on rates for cable service or video service to an  
5 individual if the individual is eligible for low-income energy assistance under s.  
6 16.27.”.

7 **2.** Page 42, line 2: after that line insert:

8 **“SECTION 70m. Initial applicability.**

9 (1m) The treatment of section 66.0420 (4m) of the statutes first applies to rates  
10 charged on the effective date of this subsection.”.
