1 **AN ACT to create** 21.19 (15) and 45.03 (21) of the statutes; **relating to:** assistance
2 for veterans affected by depleted uranium.

Analysis by the Legislative Reference Bureau

This bill requires the adjutant general and the Department of Veterans Affairs (DVA) to assist national guard members and veterans who may have been exposed to depleted uranium in obtaining the best practice health screening test from the federal government to test for exposure to depleted uranium.

Under the bill, DVA, with the help of the adjutant general, must provide information to veterans, upon their discharge from active duty, regarding the health and safety issues concerning depleted uranium exposure, the tests used to detect that exposure, the treatments available for that exposure, and the federal and state benefits available to veterans affected by that exposure. The bill also requires DVA to provide that information to DVA staff, veterans organizations, health care providers, and county veterans service officers, and to put that information on the Internet.

The bill creates a committee to study the affects of exposure to depleted uranium and other hazardous materials on veterans and national guard members and to submit a report with any recommended legislation to the governor and legislature.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

1 **SECTION 1.** 21.19 (15) of the statutes is created to read:

2 **21.19 (15)** The adjutant general shall assist national guard members who may
3 have been exposed to depleted uranium in obtaining the best practice health
4 screening test from the federal department of veterans affairs to test for exposure to
5 depleted uranium using a bioassay procedure involving methods sufficiently
6 sensitive to detect depleted uranium at low levels.

7 **SECTION 2.** 45.03 (21) of the statutes is created to read:

8 **45.03 (21) DEPLETED URANIUM; ASSISTANCE TO VETERANS.** The department shall
9 do all of the following for veterans who may have been affected by exposure to
10 depleted uranium while on active duty:

11 (a) Assist veterans who may have been exposed to depleted uranium to obtain
12 the best practice health screening test from the federal department of veterans
13 affairs to test for exposure to depleted uranium using a bioassay procedure involving
14 methods sufficiently sensitive to detect depleted uranium at low levels.

15 (b) With the assistance of the department of military affairs, provide
16 information to veterans upon their discharge from active duty regarding the health
17 and safety issues concerning depleted uranium exposure, including the types and
18 efficacy of tests to detect depleted uranium exposure, the treatments available for
19 veterans affected by exposure to depleted uranium, and the federal and state
20 benefits that are available for veterans exposed to depleted uranium.

1 (c) Provide information to departmental staff, interested veterans
2 organizations, health care providers, and county veterans service officers regarding
3 the effects of depleted uranium exposure, the detection programs that are available
4 to determine if a veteran has been exposed to depleted uranium, the federal
5 treatment programs that are available to veterans who may have been exposed to
6 depleted uranium, and the federal and state benefits that are available to veterans
7 who have been exposed to depleted uranium.

8 (d) Create information on the Internet about the health effects of depleted
9 uranium exposure, the detection programs that are available to determine if a
10 national guard member or veteran has been exposed to depleted uranium, the federal
11 treatment programs that are available to those who may have been exposed to
12 depleted uranium, and the federal and state benefits that are available to those
13 national guard members or veterans who have been exposed to depleted uranium.

15 (1) DEPLETED URANIUM STUDY COMMITTEE. There is created a depleted uranium
16 study committee, which shall consist of one member appointed by the senate
17 majority leader, one member appointed by the senate minority leader, one member
18 appointed by the speaker of the assembly, one member appointed by the assembly
19 minority leader, one member appointed by the adjutant general, one member
20 appointed by the secretary of the department of veterans affairs, one member
21 appointed by the secretary of the department of health and family services, 2
22 members appointed by the committee who are veterans with knowledge of or
23 experience with exposure to hazardous materials, one county veterans service officer
24 appointed by the County Veterans Service Officer Association of Wisconsin, and 2
25 members appointed by the committee who are physicians or scientists with

1 knowledge of or experience with exposure to hazardous materials. The committee
2 shall designate one of its members as the chairperson. The committee shall study
3 the health effects on veterans of the U.S. armed forces, including members of the
4 national guard activated into the U.S. armed forces, to exposure to depleted uranium
5 and other hazardous materials. The committee shall evaluate the current
6 information provided to national guard members and veterans regarding exposure
7 to depleted uranium and other hazardous materials, the tests and medical
8 treatments available for national guard members and veterans exposed to depleted
9 uranium and other hazardous materials, and the federal and state benefits available
10 to national guard members and veterans exposed to depleted uranium and other
11 hazardous materials. The departments of health and family services, military
12 affairs, and veterans affairs shall assist the committee in fulfilling its
13 responsibilities under this subsection. On or before January 15, 2009, the committee
14 shall submit a report, with any recommended legislation, regarding the training,
15 medical treatment, and benefits available to national guard members and veterans
16 exposed to depleted uranium and other hazardous materials, to the governor and to
17 the legislature for distribution to the appropriate standing committees in the
18 manner provided under section 13.172 (3) of the statutes. The committee shall cease
19 to exist when the committee has submitted the report or on January 15, 2009,
20 whichever occurs sooner.
