Additionally, in a separate Senate amendment, I would like the privacy language you spoke with John & David about. If there's questions about this, please contact them.

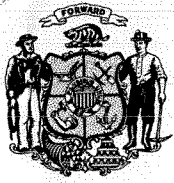
\* Finally, in a separate Senate amendment, I would like to remove the photo/video requirement (page 6, lines 7-8).
