

- 1 At the locations indicated, amend the ~~substitute amendment~~ as follows:
- 2 1. Page 5, line 23: after that line insert:
 3 (c) Except as provided under sub. (4), a scrap metal dealer may disclose
 4 personally identifiable information recorded or maintained under this subsection
 5 only to a successor in interest to the scrap metal dealer, including a successor in
 6 interest that arises as a result of a merger, sale, assignment, restructuring, or change
 7 of control.”
- 8 2. Page 5, line 25: delete the material beginning with “or” and ending with
 9 “entity” on page 6, line 1.
 10 3. Page 6, line 17: after that line insert:
