Could you please draft the following amendment to whatever the latest version of SB 485 is.

Add a new provision to the bill. Amend existing 125.06 (11) to say:

(11) Auction sales. The sale by an auction house at public auction of a collection of sealed bottles of intoxicating liquor or unopened beer cans for the purpose of settling an estate or disposing of the collection **or the sale of wine by a charitable organization at an auction held to raise money for the charitable organization.**
