1 At the locations indicated, amend the bill as follows:

2 1. Page 47, line 14: delete lines 14 to 20 and substitute:

3 "SECTION 113m. 227.21 (2) (a) of the statutes, as affected by 2007 Wisconsin
4 Act 20, is amended to read:

5 227.21 (2) (a) Except as provided in s. 601.41 (3) (b), to avoid unnecessary
6 expense an agency may, with the consent of the legislative reference bureau and the
7 attorney general, adopt standards established by technical societies and
8 organizations of recognized national standing by incorporating the standards in its
9 rules by reference to the specific issue or issues of the publication in which they
10 appear, without reproducing the standards in full."
