3 2. Page 7, line 14: after that line insert:

4 "SECTION 12g. 146.555 of the statutes is created to read:

5 146.555 **Cardiocerebral resuscitation.** Any person who offers certification
6 in cardiopulmonary resuscitation shall provide the written information on
7 cardiocerebral resuscitation that is prepared by the emergency medical services
8 board under s. 146.58 (9) to each individual to whom the person provides instruction
9 in cardiopulmonary resuscitation.

10 SECTION 12m. 146.58 (9) of the statutes is created to read:

11 146.58 (9) Prepare written information on cardiocerebral resuscitation and
12 provide the information to persons who offer certification in cardiopulmonary
13 resuscitation."
