At the locations indicated, amend the bill as follows:

**1.** Page 2, line 1: on lines 1 and 7, delete "20.395 (5) (er)" and substitute "20.435 (5) (g)".

**2.** Page 2, line 2: delete "20.395 (5) (er)" and substitute "20.435 (5) (g)".

**3.** Page 2, line 3: on lines 3 and 4, delete "85.109" and substitute "250.17".

**4.** Page 2, line 3: after that line insert:

"SECTION 1m. 25.40 (1) (a) 24. of the statutes is created to read:

25.40 (1) (a) 24. Moneys received under s. 341.14 (6r) (b) 11. that are deposited into the general fund and credited to the appropriation account under s. 20.435 (5) (g)."

**5.** Page 2, line 5: delete "85.109" and substitute "250.17".

**6.** Page 4, line 7: delete "\$27,600" and substitute "\$43,200".
