1 AN ACT *to amend* 29.001 (36), 29.089 (3), 29.161, 29.194 (1) (a), 29.204, 29.207,
2 29.231 (2), 29.231 (3), 29.235 (2), 29.235 (2m) and 29.971 (2) (intro.); and *to*
3 *create* 29.162, 29.194 (4), 29.314 (4) (b) 2g., 29.314 (5) (b) 2g., 29.563 (2) (a) 4m.,
4 29.563 (2) (a) 4r., 29.563 (2) (b) 2m. and 29.971 (10) of the statutes; **relating to:**
5 issuing licenses to hunt feral pigs and providing a penalty.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

6 SECTION ~~1~~^{1m.} 29.001 (36) of the statutes is amended to read:

7 29.001 (36) "Game animals" includes deer, moose, elk, bear, rabbits, squirrels,
8 feral pigs, fox, and raccoon.

9 SECTION 2. 29.089 (3) of the statutes is amended to read:

10 29.089 (3) A person may hunt deer, elk, wild turkeys, feral pigs, or small game
11 in a state park, or in a portion of a state park, if the department has authorized by
12 rule the hunting of that type of game in the state park, or in the portion of the state

1 park, and, except as provided in s. 29.063 (5), if the person holds the approvals
2 required under this chapter for hunting that type of game.

3 SECTION 3. 29.161 of the statutes is amended to read:

4 **29.161 Resident small game hunting license.** A resident small game
5 hunting license shall be issued subject to ss. 29.024 and 54.25 (2) (c) 1. d. by the
6 department to any resident applying for this license. The resident small game
7 hunting license does not authorize the hunting of bear, deer, elk, ~~or~~ wild turkey, or
8 feral pigs.

9 SECTION 4. 29.162 of the statutes is created to read:

10 **29.162 Feral pig hunting licenses. (1) (a)** A resident feral pig hunting
11 license shall be issued subject to ss. 29.024 and 54.25 (2) (c) 1. d. by the department
12 to any resident applying for this license.

13 (b) A nonresident feral pig hunting license shall be issued by the department
14 to any nonresident applying for this license.

15 (2) A feral pig hunting license authorizes the hunting of feral pigs with a
16 firearm or with a bow and arrow.

17 SECTION 5. 29.194 (1) (a) of the statutes is amended to read:

18 29.194 (1) (a) Notwithstanding ss. 29.024 (2) and 29.228 (1) (a), the department
19 shall issue a resident fishing license, resident small game hunting license, resident
20 feral pig hunting license, or resident deer hunting license to a qualified student
21 applying for the license. A qualified student is a person who exhibits proof that he
22 or she is a registered full-time student who is present in this state attending a public
23 or private college or university that is located in this state and that offers an associate
24 degree or a bachelor's degree or that he or she is a citizen of a foreign country

1 temporarily residing in this state while attending a high school located in this state
2 or an agricultural short course at the University of Wisconsin System.

3 SECTION 6. 29.194 (4) of the statutes is created to read:

4 29.194 (4) RESIDENT FERAL PIG HUNTING LICENSE. A resident feral pig hunting
5 license shall be issued by the department to any member of the U.S. armed forces
6 applying for this license who exhibits proof that he or she is in active service with the
7 armed forces and that he or she is a resident on furlough or leave.

8 SECTION 7. 29.204 of the statutes is amended to read:

9 **29.204 Nonresident annual small game hunting license.** A nonresident
10 annual small game hunting license shall be issued subject to s. 29.024 by the
11 department to any nonresident applying for this license. The nonresident annual
12 small game hunting license authorizes the hunting of small game during the
13 appropriate open season but does not authorize the hunting of deer, elk, bear, wild
14 turkey, feral pigs, or fur-bearing animals.

15 SECTION 8. 29.207 of the statutes is amended to read:

16 **29.207 Nonresident 5-day small game hunting license.** A nonresident
17 5-day small game hunting license shall be issued subject to s. 29.024 by the
18 department to any nonresident applying for this license. The nonresident 5-day
19 small game hunting license authorizes the hunting of small game for which there is
20 an open season during the 5-day period for which it is issued but does not authorize
21 the hunting of deer, elk, bear, wild turkey, feral pigs, or fur-bearing animals.

22 SECTION 9. 29.231 (2) of the statutes is amended to read:

23 29.231 (2) A resident sports license confers upon the licensee all of the
24 combined privileges conferred by a resident small game hunting license, resident

1 fishing license, resident feral pig hunting license, and resident deer hunting license
2 subject to all of the duties, conditions, limitations and restrictions of those licenses.

3 SECTION 10. 29.231 (3) of the statutes is amended to read:

4 29.231 (3) A nonresident sports license confers upon the licensee all of the
5 combined privileges conferred by a nonresident small game hunting license,
6 nonresident fishing license, nonresident feral pig hunting license, and nonresident
7 deer hunting license subject to all of the duties, conditions, limitations and
8 restrictions of those licenses.

9 SECTION 11. 29.235 (2) of the statutes is amended to read:

10 29.235 (2) AUTHORIZATION; RESIDENT HUNTING, FISHING, AND TRAPPING PRIVILEGES.
11 A resident conservation patron license confers upon the licensee all the combined
12 privileges conferred by a resident small game hunting license, a resident feral pig
13 hunting license, a resident deer hunting license, a resident wild turkey hunting
14 license, a resident archer hunting license, a waterfowl hunting stamp, a pheasant
15 hunting stamp, a wild turkey hunting stamp, a resident annual fishing license, an
16 inland waters trout stamp, a Great Lakes trout and salmon stamp, a sturgeon hook
17 and line tag, and a trapping license.

18 SECTION 12. 29.235 (2m) of the statutes is amended to read:

19 29.235 (2m) AUTHORIZATION; NONRESIDENT HUNTING, FISHING, AND TRAPPING
20 PRIVILEGES. A nonresident conservation patron license confers upon the licensee all
21 the combined privileges conferred by a nonresident small game hunting license, a
22 nonresident feral pig hunting license, a nonresident deer hunting license, a
23 nonresident wild turkey hunting license, a nonresident archer hunting license, a
24 waterfowl hunting stamp, a pheasant hunting stamp, a wild turkey hunting stamp,



1 a nonresident annual fishing license, an inland waters trout stamp, a Great Lakes
2 trout and salmon stamp, and a sturgeon hook and line tag, and a trapping license.

3 SECTION 13. 29.314 (4) (b) 2g. of the statutes is created to read:

4 29.314 (4) (b) 2g. To a person who possesses or uses a night vision scope while
5 hunting feral pigs.

6 SECTION 14. 29.314 (5) (b) 2g. of the statutes is created to read:

7 29.314 (5) (b) 2g. To a person who possesses or uses a night vision scope while
8 hunting feral pigs.

9 SECTION 15. 29.563 (2) (a) 4m. of the statutes is created to read:

10 29.563 (2) (a) 4m. Feral pig: \$9.25.

11 SECTION 16. 29.563 (2) (a) 4r. of the statutes is created to read:

22 by the payment of a natural resources restitution surcharge equal to the amount of
23 the fee for the license that was required and should have been obtained.
