TO 2007 SENATE BILL 86

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 1, line 4: after "(br)" insert "1."
- 3 **2.** Page 1, line 6: delete "The bureau" and substitute "Except as provided in
4 subd. 2, the bureau".
- 5 **3.** Page 1, line 7: after "investigation." insert "If the bureau has a bureau
6 employee investigate the report, the employee may consult with any state
7 department, board, commission, or independent agency for any purpose related to
8 the investigation."
- 9 **4.** Page 2, line 6: after that line insert:
10 "2. In lieu of requiring a bureau employee to conduct an investigation of a report
11 received under subd. 1, the bureau may refer a report to a state department, board,
12 commission, or independent agency for investigation. The state department, board,

1 commission, or independent agency shall conduct the investigation and deliver the
2 results of the investigation to the bureau in a timely manner.”.

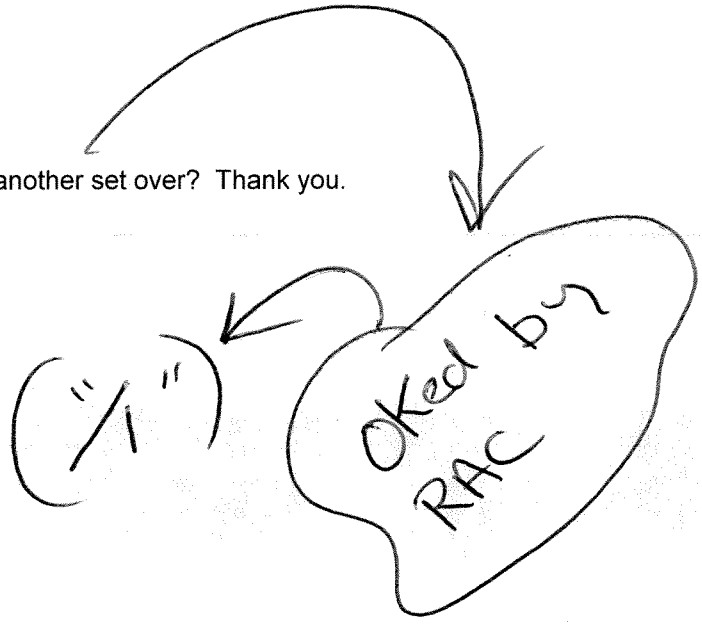
