Hi Debora,

Rep. Hines and Rep. Wasserman would like to put in a drafting request for an amendment to AB 483 to create S. 66.0119(2m) using the following language:

2m) If a local health officer or his or her designee undertakes an inspection under sub. (2) in an emergency without a special inspection warrant, the local health officer or his or her designee shall report the inspection with the appropriate local board of health, as defined in s. 250.01(3). The report shall be filed within 15 working days of completion of the inspection and shall include a summary of the reasons that justified the emergency inspection without obtaining a special inspection warrant.

If you could get us the draft as soon as possible we would really appreciate it as the bill is up for a vote in the Assembly tomorrow.
