Here's the federal definition of who is and who is not eligible for a Gold Star, at 10 U.S.C. 1126 -- <a href="http://uscode.house.gov/uscode-cgi/fastweb.exe?getdoc+uscview+t09t12+774+81++%28blue%20star%20banner%29%20%20%20%20%20%20%20%20%20%20

You will note that those serving stateside, and those no longer in service (including deaths resulting from service-connected disabilities) are not among that select group.

The criteria include the deaths of U.S. military service members:

- [Pre-1958 wars, incl. WWI, WWII]
 - (1) who lost their lives during World War I, World War II, or during any subsequent period of armed hostilities in which the United States was engaged before July 1, 1958;
- [1958+ wars, conflicts, expeditionary encounters, joint/combined operations]
 - (2) who lost or lose their lives after June 30, 1958 (A) while engaged in an action against an enemy of the United States; (B) while engaged in military operations involving conflict with an opposing foreign force; or (C) while serving with friendly foreign forces engaged in an armed conflict in which the United States is not a belligerent party against an opposing armed force; or
- [1973+ Terrorist acts, Peacekeeping operations]
 - (3) who lost or lose their lives after March 28, 1973, as a result of (A) an international terrorist attack against the United States or a foreign nation friendly to the United States, recognized as such an attack by the Secretary of Defense; or (B) military operations while serving outside the United States (including the commonwealths, territories, and possessions of the United States) as part of a peacekeeping force.

Below is the text of an e-mail (italicized) that Anthony Hardie (EA at DVA) sent to Sec. John Scocos at DVA explaining our request for a change in the Gold Star license plate. I believe it is the intent that the family would be eligible for the "gold star" special plate only if clause [1] and also either clause [2], [3], or [4] apply, but I want Anthony to verify this since he is well experienced and versed in military verbiage.

Anthony, can you please verify with Aaron our intent?

WISDOT has confirmed with a legislative office that they [DOT] take a narrow interpretation of the language "die in combat" with regards to the new Gold Star family license plates (see the email below).

After verification by the legislative office following a constituent's inquiry, the legislative office confirmed that WISDOT does not consider "die in combat" with regards to these license plates to include military service members who:

- 1) die in a combat theatre of operations (i.e. Iraq) due to accidental causes (such as a Humvee overturning, drowning, etc.);
- 2) die in a military operation for which an Armed Forces Expeditionary Medal or Global War on Terrorism Expeditionary Medal is awarded but which is not formally a "combat" operation (i.e. Lebanon, Somalia, Grenada, Panama.
- 3) die in a terrorist attack like the military service members killed in the Pentagon on 9/11.

The legislator wants a recommendation on how that this language could be expanded to include these categories of individuals, but not to go so far as to expand it to a service member who dies in an accident or other non-combat cause outside a wartime theater of operations or an AFEM-type military operation in an accident, or who dies later in life due to a service-connected disability.

Hi Rob.

I'm having difficulty figuring out the intent behind this proposed language. For ease of discussion, I have inserted numbers in blue brackets to easily reference the various clauses.

Is the intent that the family would be eligible for the "gold star" special plate if any of these clauses [1] to [4] apply? Or is it only if clause [1] and also either clause [2], [3], or [4] apply? I assumed it was the former, but when I discussed it with our veterans affairs drafter he thought it could possibly be the latter.

If in fact it is the former, I am having conceptual difficulty with the language. I understand that the proposed language under clause [1] would broaden eligiblity for the plates to allow plates for those who have lost loved ones serving in national guard units as well as the U.S. military, and would remove the "combat" restriction. From what I can discover on the internet, however, the medals referenced in clause [3] are limited to service members, so isn't this language in clause [3] duplicative of clause [1] and unnecessary? And I am not sure what the "combat theater of operation" language is intended to convey in clause [2] if not service members (which are already covered by clause [1]) - is it intended to cover private contractors, those working for other branches of the federal government (state department, Central Intelligence Agency, etc.), even journalists? The "gold star" plates issued under s. 341.14 (6r) (f) 19m. were intended to correspond to the various organizations for "gold star families," those who have had loved ones die during military service. The "terrorist

attack" language in clause [4] is broader - it would cover any family who lost a loved one as a result of domestic as well as foreign terrorist attacks, including the 9/11 attacks and Oklahoma City bombings, which, if this is the intent, doesn't seem to fit with the original "gold star families" association of the plate. (Another option would be to create a different plate for those who have lost loved ones in terrorist attacks, with a different design for the plates.)

Any assistance you can provide to help me understand the intent here would be greatly appreciated.



Analysis by the Legislative Reference Bureau

Under current law, any group or organization may apply to the Department of Transportation (DOT) for designation as an authorized special group. If the application is approved, members of the authorized special group may obtain special distinguishing registration plates for certain vehicles, including automobiles and motor homes, that are owned or leased by special group members. A fee, in addition to the regular registration fee for the particular kind of vehicle, is assessed for the issuance or reissuance of most special plates.

Before October 2, 1998, authorized special groups whose members may obtain special distinguishing registration plates were specifically enumerated in state law. Current law provides that specific enumeration in state law of authorized special groups is limited to those special groups enumerated before October 2, 1998. In 2005 Wisconsin Act 25 (the biennial budget bill), a special group was enumerated for persons who have had an immediate family member die in combat while serving in the U.S. armed forces. The design of these special plates, which are colored red, white, and blue, must include a gold star flag.

Under current federal law, gold star lapel buttons may be furnished to the widows, parents, and next of kin of members of the armed forces who lost their lives: \$1) during World War I, World War II, or during any subsequent period of armed hostilities in which the United States was engaged before July 1, 1958; \$2) after June 30, 1958 while engaged in an action against an enemy of the United States, while

engaged in military operations involving conflict with an opposing foreign force, or while serving with friendly foreign forces engaged in an armed conflict in which the United States was not a belligerent party against an opposing armed force; or 33 after March 28, 1973, as a result of an international terrorist attack against the United States or a foreign nation friendly to the United States or as a result of military operations while serving outside the United States as part of a peacekeeping force.

This bill makes changes to who may obtain these "gold star" special plates by identifying the special group as persons who have had an immediate family member die while serving in the U.S. armed forces or in forces incorporated as part of the U.S. armed forces if the immediate family member meets any of the eligibility criteria specified under federal law for a gold star lapel button. The bill does not change the definition under current law for "immediate family member."
