	The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

6	27.01 (7) (c) 11. Any vehicle, except a motor bus, occupied by a state resident
7	who produces evidence that shows that he or she is a veteran, as defined in 38 USC
8	101, and is receiving disability compensation benefits under 38 USC 1101 to 1163 as
9	individually unemployable under 38 USC 1502 or for disabilities that result in a
10	disability rating that is 70 percent or greater under 38 USC 1114.

**SECTION 2.** 27.01 (7) (c) 12. of the statutes is created to read:

**SECTION 6. Effective date.** 

27.01 (7) (c) 12. Any vehicle, except a motor bus, occupied by a state resident	
who produces evidence that shows that he or she was a member of the U.S. armed	
services and was held as a prisoner of war during a war period, as defined in s. $45.01$	
(13), or while in service in a crisis zone, as defined in s. 45.01 (11).	
<b>SECTION 3.</b> 27.01 (8) (a) of the statutes is amended to read:	
27.01 (8) (a) Admission fee. Except as provided under par. pars. (b) and (bn),	
the department may charge a person an admission fee to enter Heritage Hill state	
park or a state trail.	
<b>SECTION 4.</b> 27.01 (8) (b) (intro.) of the statutes is amended to read:	
27.01 <b>(8)</b> (b) Exemptions: Heritage Hill and state trails. (intro.) No admission	
fee <u>to enter Heritage Hill State Park or any state trail</u> may be charged for <u>entry by</u>	
any of the following:	
<b>SECTION 5.</b> 27.01 (8) (bn) of the statutes is created to read:	
27.01 <b>(8)</b> (bn) <i>Exemptions; state trails only.</i> No admission fee to enter any state	
trail may be charged for entry by any of the following:	
1. Any state resident who produces evidence that shows that he or she is a	
veteran, as defined in 38 USC 101, and is receiving disability compensation benefits	
under 38 USC 1101 to 1163 as individually unemployable under 38 USC 1502 or for $$	
disabilities that result in a disability rating that is 70 percent or greater under 38	
USC 1114.	
2. Any state resident who produces evidence that shows that he or she was a	
member of the U.S. armed services and was held as a prisoner of war during a war	
period, as defined in s. $45.01$ (13), or while in service in a crisis zone, as defined in	
s. 45.01 (11).
