AN ACT to create 1.14 of the statutes; **relating to:** ~~flying~~ of the United States flag at public buildings, structures, and facilities.

Analysis by the Legislative Reference Bureau

This bill requires that each state agency, state authority, and local governmental unit in this state ensure that each United States flag that is flown at each building, structure, or facility that is owned or occupied entirely by the agency, authority, or unit is manufactured in the United States. The bill does not specify a penalty for violations, but the bill's provisions are enforceable through the court system.
