SUBJECT: OCI Legislation

The Office of the Commissioner of Insurance (OCI) has prepared a list of proposed statutory language. Following, is a summary of each of the proposals along with suggested statutory language. Please draft statutory language needed to implement the proposals.

1. **LRB 3368/5.** OCI is resubmitting the contents of LRB 3368/5 along with this drafting request to create a new legislative draft to present for introduction by the legislature. Please review the initial applicability and the effective dates sections for revision.
2. **Premium tax statute of limitations.** Amend s. 76.68, Wis. Stat. to strengthen the language on the time period in which suit may be brought against the state related to premium tax grievances. Does not change current six month time period for permissive suit. Proposed language will more accurately reflect payment and notice processes and the exclusive remedy and required suit within 6 months from payment provisions.
3. **Amend 628.347 to make section applicable to all consumers and not restricted to senior consumers.**
4. **Interstate Insurance Compact.** Please see attached LRB – 4355/P1 draft language.
5. **Policy form review.** Amend 631.20, Wis. Stats. to allow the Office to implement a file and use process for policy form filings. Currently, the Office reviews and approves all personal lines policy forms before they may be used. Under the proposal, filings would still be required prior to use.
