

The changes Senator Plale would like to see are to state statute 340.01(72)(a)

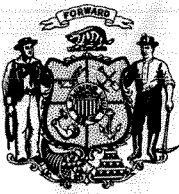
Current language would change to read:

Analysis by the Legislative Reference Bureau

Under current law, a person who transports motor vehicles, trailers, semitrailers, or recreational vehicles, either by towing on the vehicles own wheels or under the vehicle's own power, may register as a transporter with the Department of Transportation (DOT) and obtain special transporter registration plates. A transporter may tow or operate one of the designated types of vehicles without the vehicle being registered with DOT, provided the transporter displays valid transporter plates upon the vehicle and transports the vehicle between certain entities involved in the sale of such vehicles, including a dealer, a distributor, the manufacturer, or a branch of the manufacturer.

This bill allows a transporter to display transporter registration plates on a motor vehicle, trailer, semitrailer, or recreational vehicle being transported from a dealer, a distributor, the manufacturer, or a branch of the manufacturer to the purchaser of such vehicle, or from the purchaser of the vehicle to a dealer, a distributor, the manufacturer, or a branch of the manufacturer.
