

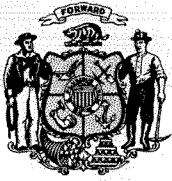

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 1, line 3: delete "revisor" and substitute "legislative reference bureau".

3 **2.** Page 2, line 19: delete the material beginning with that line and ending with

4 page 3, line 6, and substitute:

5 "SECTION 5m. 227.21 (2) (a) of the statutes, as affected by 2007 Wisconsin Act  
6 20, is amended to read:

7 227.21 (2) (a) Except as provided in s. 601.41 (3) (b), to avoid unnecessary  
8 expense an agency may, with the consent of the legislative reference bureau and the  
9 attorney general, adopt standards established by technical societies and  
10 organizations of recognized national standing by incorporating the standards in its

1 rules by reference to the specific issue or issues of the publication in which they  
2 appear, without reproducing the standards in full.”
