(am) to (d) and s. 125.185 (5), the village board of any village in the northern geographical half of Ozaukee County having a population of more than 4,000 or a city in the southern geographical half of Milwaukee County, which borders Lake Michigan and has a population of less than 15,000, may issue, to any applicant designated by the village board or city council, one "Class B" license in addition to the number of licenses determined for the village's quota under pars. (b) to (d).
