Section 2 145.20(6)

(b) "Install, design, maintain, repair, or sell a private sewage system, component of a private sewage system, ..."

Currently, it reads "private sewage systems component of a ..."

2 ✓ **1.** Page 2, line 7: delete "A governmental" and substitute "(a) Except as
3 provided in par. (b), a governmental".

4 ✓ **2.** Page 2, line 10: substitute "1." for "(a)".

5 ✓ **3.** Page 2, line 13: substitute "2." for "(b)".

6 ✓ **4.** Page 2, line 16: after that line insert:

7 "(b) Paragraph (a) does not apply to activities performed by an employee on
8 property owned by the employee that is outside of the governmental unit for which
9 the employee works."
