6 **SECTION 5.** 101.16 (1) (a) of the statutes is created to read:

7 101.16 (1) (a) “Department of transportation cylinder” means a container that
8 holds liquefied petroleum gas and that meets the specifications established by the
9 federal department of transportation.

10 **SECTION 6.** 101.16 (1) (b) 1. to 4. of the statutes are created to read:

11 101.16 (1) (b) 1. Propane.

12 2. Propylene.

13 3. Butane.

14 4. Butylene.

15 **SECTION 7.** 101.16 (1) (c) of the statutes is created to read:

16 101.16 (1) (c) “Propane gas system” means an assembly consisting of one or
17 more containers that has a total water capacity of at least 100 gallons and a means
18 of conveying propane gas from the container or containers to a point of connection
19 with devices used to consume the propane gas. A “propane gas system” includes all
20 piping and other components associated with the assembly that are used to control
21 the quantity, flow, pressure, and physical state of the propane gas.

22 **SECTION 8.** 101.16 (1) (d) of the statutes is created to read:

23 101.16 (1) (d) “Retail supplier” means a person engaged in the business of
24 filling containers that have a water capacity of at least 4 pounds with liquefied
25 petroleum gas that is intended to be used directly from the containers as fuel. “Retail

1 supplier” does not include a person who fills such containers with liquefied
2 petroleum gas for the person’s own use.

3 **SECTION 9.** 101.16 (2) of the statutes is amended to read:

4 101.16 (2) RULES. The department shall promulgate rules to ascertain, fix, and
5 order such reasonable standards, rules, or regulations for the design, construction,
6 location, installation, operation, repair, and maintenance of equipment for storage,

21 **SECTION 12.** 101.16 (3) (b) of the statutes is created to read:

22 101.16 (3) (b) A retail supplier may evacuate a liquefied petroleum gas
23 container not under its ownership in order to transfer the remaining liquefied
24 petroleum gas that is in that container into a container that is under its ownership.

25 **SECTION 13.** 101.16 (3g) of the statutes is created to read:

1 **101.16 (3g) LICENSE REQUIRED.** (a) No retail supplier may distribute liquefied
2 petroleum gas without holding a license issued by the department. The department,
3 subject to s. 101.02 (20) and (21), shall issue a license to be a retail supplier upon
4 receiving the fee established under s. 101.19 (1) (L) or (1m) and upon obtaining proof
5 of financial responsibility as required under sub. (3r) (c). The term of the license shall
6 be set by the department, not to exceed 2 years.

7 (b) The department shall publish an annual list of all retail suppliers holding
8 valid licenses under par. (a).

9 **SECTION 14.** 101.16 (3r) of the statutes is created to read:

10 **101.16 (3r) FINANCIAL RESPONSIBILITY.** (a) Except as provided in par. (b), a retail
11 supplier shall maintain proof of financial responsibility in the amount of \$1,000,000
12 per occurrence with an annual aggregate of \$2,000,000 for compensating 3rd parties
13 for bodily injury and property damages for incidents associated with the release of
14 liquefied petroleum gas.

15 (b) A retail supplier who only fills department of transportation cylinders or
16 who only fills containers for engine and recreational vehicle fueling systems shall
17 maintain proof of financial responsibility in the amount of \$500,000 per occurrence
18 with an annual aggregate of \$1,000,000 for compensating 3rd parties for bodily
19 injury and property damages for incidents associated with the release of liquefied
20 petroleum gas.

21 (c) A retail supplier may obtain any of the following to prove financial
22 responsibility as required under par. (a) or (b):

23 1. A surety bond that is issued by a surety company that is listed as an
24 acceptable surety for federal bonds on the date that the surety bond is obtained in
25 the most recently published U.S. department of the treasury's circular 570.

1 2. An irrevocable letter of credit that is issued by a financial institution that
2 is authorized to do business in this state or that is federally chartered. The letter of
3 credit shall be for an initial period of at least one year.

4 3. Commercial general liability insurance as an endorsement to an existing
5 policy or as a separate policy from an insurer, or a risk retention group, that is
6 licensed to transact the business of insurance in this state or that is eligible to
7 provide insurance as a surplus lines insurer in one or more states.

8 (d) A retail supplier who fails to maintain proof of financial responsibility as
9 required under par. (a) or (b), may not distribute liquefied petroleum gas at retail
10 until such proof is obtained.

11 (e) Each retail supplier shall file proof of financial responsibility as required
12 under this subsection with the department.

13 (f) A 3rd party that issues a surety bond, letter of credit, or general liability
14 insurance to a retail supplier for purposes of this subsection shall provide written
15 notice to the retail supplier and to the department at least 60 days before canceling,
16 revoking, suspending, or failing to renew the bond, letter, or insurance.

17 (g) A retail supplier that cancels or fails to renew a surety bond, letter of credit,
18 or general liability insurance shall notify the department at least 60 days before
19 cancelling or failing to renew the bond, letter, or insurance. Upon receipt of the
20 notice, the department shall revoke the retail supplier's license issued under sub.
21 (3g).

22 (h) A financial institution that issues an irrevocable letter of credit to a retail
23 supplier for purposes of this subsection shall renew the letter automatically unless
24 notice is given as required under par. (f).

8 the equipment, a statement, the form of which shall be prescribed by the department,

12 **SECTION 17.** 101.16 (4) (b) of the statutes is created to read:

13 101.16 (4) (b) 1. A person who owns, leases, or uses a propane gas system and
14 who is a customer of a retail supplier shall notify the retail supplier of propane gas
15 for the propane gas system of any interruption in the operation of the propane gas
16 system due to the replacement, modification, repair, or servicing of the propane gas
17 system by any person other than the retail supplier. The customer shall provide the
18 notice at least 7 days in advance of the the interruption in the operation of the
19 propane gas system, except as provided in subd. 2. The retail supplier, or the person
20 replacing, modifying, repairing, or servicing the propane gas system, shall perform
21 a check for leaks or other defects in the propane gas system before placing the
22 propane gas system back into operation in the manner required by rule.

23 2. If the interruption of a propane gas system subject to subd. 1. is due to
24 emergency repair or servicing, the customer shall provide the notice to the retail

1 supplier as soon as possible and no later than 24 hours after the repair or servicing
2 is completed.

3 **SECTION 18.** 101.16 (4) (c) of the statutes is created to read:

4 101.16 (4) (c) Each retail supplier filling a container that is part of a propane
5 gas system shall provide written notice to each customer subject to par. (b) of the
6 customer's duty under par. (b) before the retail supplier's first delivery of propane gas
7 to that customer and shall provide subsequent notices on an annual basis. The notice
8 shall include all of the following information concerning the duty to notify under par.
9 (b):

- 10 1. The name, address, and telephone number of the retail supplier.
- 11 2. The purpose of giving the notification to the retail supplier.
- 12 3. A description of the type of propane gas system that is subject to the
13 notification requirement.
- 14 4. A description of the types of activities that constitute a replacement,
15 modification, repair, or servicing of a propane gas system.
- 16 5. A copy of the provisions under s. 101.16 (4) (b).

19 **SECTION 20.** 101.16 (5) of the statutes is renumbered 101.16 (5) (am) and
20 amended to read:

22 ~~section, who intentionally violates sub. (3) or (4) or any standard, rule or regulation~~
23 ~~adopted by the department pursuant to this section, or issuing a false statement~~
24 ~~under sub. (4), promulgated under sub. (2)~~ shall be fined not less than \$25 nor more

1 than ~~\$100~~ \$2,000, or shall be imprisoned not less than 30 days nor more than 6
2 months.

3 **SECTION 21.** 101.16 (5) (ac) of the statutes is created to read:

4 101.16 (5) (ac) Except as provided in par. (am), any person who violates sub.
5 (3) or (4) or any rule promulgated under sub. (2) shall forfeit not less than \$10 nor
6 more than \$1,000.

8 101.16 (5) (b) Except as provided in par. (c), any retail supplier who violates
9 sub. (3g) or (3r) shall forfeit not less than \$500 and not more than \$1,000 for the first

14 less than \$200 and not more than \$400 for the first offense and not less than \$800
15 but not more than \$2,000 for each subsequent offense if the retail supplier is one of
16 the following:

- 17 1. A retail supplier who only fills department of transportation cylinders.
18 2. A retail supplier who only fills containers for engine and recreational vehicle
19 fueling systems.

25 intentionally violates sub. (3g) or (3r) shall be imprisoned not less than 30 days nor

1 more than 6 months or shall be fined not less than \$500 nor more than \$1,000 for the
2 first offense and not less than \$2,000 nor more than \$5,000 for each subsequent
3 offense.

4 **SECTION 23k.** 101.16 (5) (cn) of the statutes is created to read:

5 101.16 (5) (cn) Any retail supplier who only fills department of transportation
6 cylinders or containers for engine and recreational vehicles and who intentionally
7 violates sub. (3g) or (3r) shall be imprisoned not less than 30 days nor more than 6
8 months or shall be fined not less than \$200 nor more than \$400 for the first offense
9 and not less than \$800 nor more than \$2,000 for each subsequent offense.

12 2. Each day of violation of sub. (3g) constitutes a separate offense.

18 at retail until the retail supplier is issued the license required under sub. (3g).

20 101.16 (5m) CIVIL LIABILITY. (a) Any retail supplier who is licensed under sub.
21 (3g) and who suffers damages caused by the filling of a container that is not a
22 department of transportation cylinder by another retail supplier who is not so
23 licensed may bring an action against the unlicensed retail supplier to do any of the
24 following:

1 1. Enjoin the unlicensed retail supplier from distributing liquefied petroleum
2 gas at retail until the retail supplier receives the required license.

3 2. Receive monetary damages equal to 3 times the amount of any monetary loss
4 sustained or \$2,000, whichever is greater, multiplied by each day that the unlicensed
5 supplier is not licensed under sub. (3g).

6 (b) Notwithstanding s. 814.04 (1), a retail supplier who prevails in an action
7 under par. (a) shall be awarded reasonable attorney fees.

8 (c) An action under this subsection shall be commenced within 180 days after
9 the cause of action accrues or be barred.

10 **SECTION 26.** 101.16 (6) of the statutes is amended to read:

11 101.16 (6) EXEMPTION. This section shall does not apply to railroads engaged
12 in interstate commerce or to equipment used by them.

13 **SECTION 27.** 101.19 (1) (L) of the statutes is created to read:

14 101.19 (1) (L) Issuing licenses to retail suppliers of liquefied petroleum gas
15 under s. 101.16 (3g), except as provided in sub. (1m).

18 license under s. 101.16 (3g) to a retail supplier who only fills department of

21 182.0175 (1) (bu) “Pavement” means asphalt or concrete pavement.

24 facilities that are owned by a person, other than a governmental unit, and that are

1 located on private property owned or leased by that person and that do not cross a
2 public right-of-way.

3 **SECTION 30.** 182.0175 (1) (c) (intro.) of the statutes is renumbered 182.0175 (1)
4 (c) and amended to read:

5 182.0175 (1) (c) “Transmission facilities” includes all pipes, pipelines, wires,
6 cables, ducts, wirelines and associated facilities, whether underground or
7 aboveground, regardless of the nature of their transmittants or of their in-service
8 application. The term includes, but is not restricted to, utility facilities,
9 government-owned facilities, facilities transporting hazardous materials,
10 communications and data facilities, drainage and water facilities and sewer systems.
11 The term does not include ~~any of the following:~~ culverts.

16 of transmission facilities, other than private transmission facilities, shall establish
17 or designate a nonprofit organization governed by a board of directors as the operator
18 of a one-call system and shall be members of the system. The one-call system shall
19 be a statewide communication system in which a single operational center receives
20 excavation notices and transmits notice information to affected-member
21 transmission facilities owners. Owners of private transmission facilities may be
22 members.

1 182.0175 **(1m)** (bm) *Membership fees.* ~~Members~~ A member may be assessed
2 an initial start-up fee equal to the system's costs in adding the member to the
3 one-call system, except that any initial start-up fee may not exceed \$100 for a
4 member whose transmission facilities serve less than 5,000 customers. For purposes
5 of assessing the initial start-up fee, affiliated transmission facilities owners shall be
6 considered a single member. Under this paragraph, a transmission facilities owner
7 is affiliated with another transmission facilities owner if the transmission facilities
8 owner, directly, or indirectly through one or more intermediaries, controls, is
9 controlled by, or is under common control with, the other transmission facilities
10 owner. Members shall also be assessed a fee per notice of intended excavation
11 activity. Membership in the one-call system ceases if a fee assessed under this
12 paragraph is more than 90 days past due. A transmission facilities owner may be
13 reinstated as a member upon payment of the amount past due.

19 affected-member transmission facilities owners who will receive the notice
20 information.

23 shall ensure, through information distributed to the public by phone, Internet, or
24 printed materials, that a person providing notice on intended excavation activity is

1 and that the person providing notice is referred to other entities to be contacted by
2 the person for determining the location of private transmission facilities. In
3 providing this information, the operator shall specifically use the term “propane” in
4 describing the type of private transmission facilities that are not subject to the
5 one-call system.

6 2. The department of commerce may promulgate a rule that requires retail
7 suppliers, as defined in s. 101.16 (1) (d), of propane to inform their customers each
8 year of the obligation of owners of transmission facilities under this section.

9 **SECTION 39.** 182.0175 (2) (am) 3. of the statutes is amended to read:

10 182.0175 (2) (am) 3. Maintain an estimated minimum clearance of 18 inches
11 between a marking for an unexposed underground transmission facility marked that
12 is marked under sub. (2m) and the cutting edge or point of any power-operated
13 excavating or earth moving equipment. If, except as is necessary at the beginning
14 of the excavation process to penetrate and remove the surface layer of pavement.
15 When the underground transmission facility is becomes exposed or if the
16 transmission facility is already exposed, the excavator may reduce the clearance to
17 2 times the known limit of control of the cutting edge or point of the equipment or 12
18 inches, whichever is greater.
