

Hi Beth,

I should be able to get it into editing for you this afternoon.

When you say "a credit card not valid for payment of a forfeiture," are you referring to a) a credit card such as one obtained through an employer like the State of Wisconsin for travel expenses that will decline payments for certain kinds of transactions as a result of limitations placed on it by the credit card account holder; b) one that has been declined for any reason including delinquency on the account or the card holder exceeding his or her credit limit; or c) some sort of credit card that simply limits the sorts of transactions for which it can be used because of a policy of the credit card issuer?

Would one of the following two options work better?

credit card, or paid with a credit card that is no longer valid or that is not valid for payment of a forfeiture, the rental or leased vehicle owner....

or

credit card, or paid with a credit card for which payment of the forfeitures and charges under this section is being declined by the issuer of the credit card, the rental or leased vehicle owner....
