② ***Analysis by the Legislative Reference Bureau***

* Under current law, an individual must be at least 18[✓] years of age to marry in
* this state unless the individual is between 16 and 18 years of age and has the written
consent of his or her parent or guardian. An applicant for a marriage license who
is under 30[✓] years of age must present to the county clerk, who issues marriage
licenses, a certified copy of his or her birth certificate. This bill removes the age
limitation for the birth certificate requirement so that every applicant for a marriage
license, regardless of age, must present to the county clerk a certified copy of his or
her birth certificate. ✓

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 SECTION 1. 765.09^x (3) (b) of the statutes is amended to read:

4 765.09 (3) (b) Each applicant for a marriage license under 30[✓] years of age shall
5 exhibit to the clerk a certified copy of a birth certificate, and each applicant shall
6 submit a copy of any judgment or death certificate affecting the applicant's marital

1 status. If any applicable birth certificate, death certificate or judgment is
2 unobtainable, other satisfactory documentary proof of the requisite facts therein
3 may be presented in lieu of the birth certificate, death certificate or judgment.
4 Whenever the clerk is not satisfied with the documentary proof presented, he or she
5 shall submit the presented proof to a judge of a court of record in the county of
6 application for an opinion as to its sufficiency.
