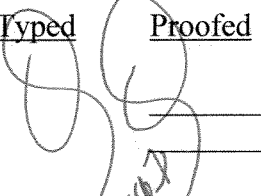

1 At the locations indicated, amend the bill as follows:

5 **2.** Page 5, line 3: after “(6).” insert “No funds may be encumbered under this
6 paragraph after the first day of the 60th month beginning after the effective date of
7 this paragraph ... [revisor inserts date].”

8 **3.** Page 5, line 11: after “council.” insert “No funds may be encumbered under
9 this paragraph after the first day of the 60th month beginning after the effective date
10 of this paragraph ... [revisor inserts date].”

11 **4.** Page 8, line 7: after that line insert:

1 “(7) [✓]SUNSET [⊙]This section does not apply after the first day of the 60th month
2 beginning after the effective date of this subsection [✓].... [revisor inserts date].”
