Include section 22 relating to the permanent endowment fund, except that I would like to go with current law of 25.69 but change the amount transferred to the Medical Assistance trust fund to \$65,000,000 in each fiscal year instead of \$50,000,000.

Include section 9221 but change the write-down amount from appropriation 20.435(4)(b) to \$15,000,000 each in FY 08 and FY 09.

Please let me know if you have any questions, and thank you in advance.

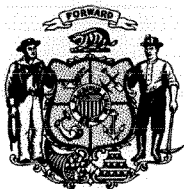
