STATE FINANCE

Currently, in any fiscal year, the secretary of administration may temporarily reallocate moneys to the general fund from other state funds in an amount not to exceed, at any one time, 5 percent of the total general purpose revenue appropriations for that fiscal year. This bill increases that amount to 10 percent during the 2007-09 fiscal biennium.

For further information see the *state* fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

2 **SECTION 9101. Nonstatutory provisions; administration.**

3 (1) TEMPORARY REALLOCATIONS TO THE GENERAL FUND. Notwithstanding section
4 20.002 (11) (b) 2. of the statutes, except as provided in section 20.002 (11) (b) 3. of the

1 statutes, the secretary of administration, during the 2007-09 fiscal biennium, shall
2 limit the total amount of any temporary reallocations to the general fund at any one
3 time during a fiscal year to an amount equal to 10 percent of the total amounts shown
4 in the schedule under section 20.005 (3) of the statues, as affected by the acts of 2007,
5 of appropriations of general purpose revenues, calculated by the secretary as of that
6 time and for that fiscal year.
