Assumptions Used in Arriving at Fiscal Estimate

BILL SUMMARY

- Defines wireless telecommunications device
- Prohibits drivers with a class D instruction permit, a class M instruction permit, or during the first nine months following issuance of a probationary license (for drivers under the age of 18) from using a cellular telephone or wireless telecommunications device while driving, except to report an emergency
- Provides a penalty of \$50 for the first violation, and up to \$100 for second and subsequent violations.

ASSUMPTIONS

- Implementation of this bill will cause additional violations, convictions and withdrawals to be reported to DMV

CONCLUSION

One-time costs: \$51,000 updating of the license restrictions, creating a new charge code, system testing
