Assumptions Used in Arriving at Fiscal Estimate

Under current law, if a person owes a debt of at least \$20 to a county or municipality, and if the debt has been reduced to a judgment or the county or municipality has provided the debtor reasonable notice and an opportunity to be heard with regards to the debt, the county or municipality may certify the debt to the Department of Revenue (DOR) so that DOR may collect the debt for the county or municipality by subtracting the amount of the debt from any tax refund owed to the debtor.

Under this bill, ambulance service providers may also certify to DOR for collection debts related to providing ambulance services to individuals in this state. The bill also authorizes the DOR to charge the debtor a fee to cover the administrative cost of the bill.

The revenue effect of the bill is expected to be minimal. The department expects to incur one time costs of \$22,100 for salary and fringe benefits that will be charged against 20.566(3)(a).
