Assumptions Used in Arriving at Fiscal Estimate

This bill creates new criminal penalties for persons in a locker room who take pictures or motion pictures of persons who are nude or partially nude, without consent. Violation of this provision is a Class B misdemeanor. Penalties are also created for persons who possess, broadcast or exhibit pictures or motion pictures taken in violation of this new criminal statute. Violation of this second provision is a Class A misdemeanor.

It is impossible to predict how many such crimes will be filed in the circuit courts. Additional proceedings require additional judge, court reporter, court staff and juror time. These costs are borne by both the state and the county. These crimes could also result in additional jail costs for the counties. An accurate estimate of the additional costs is impossible with the data available.
