### Assumptions Used in Arriving at Fiscal Estimate

This bill would include the employees of regional transit authorities created under this bill as participants of the Wisconsin Retirement System (WRS). For the purposes of this estimate, it is assumed that employees of a newly created regional transit authority would be individuals previously employed by the local units of government that created the transit authority. As such, it is estimated that there would be no additional costs to local governments related to the WRS.
