To the Honorable, the Legislature:

According to Wisconsin School Law 121.87 in accordance with 13.172, the Board is required by law to submit the enclosed reports. School Law 121.87 states "...annually by May 1 the board of school directors of the school district operating under ch. [119](#) shall submit a report to the legislature under s. [13.172\(2\)](#) that specifies the number, percentage, race, sex, grade and attendance area of pupils transferred outside their attendance area without written consent under s. [121.85\(6\)\(am\)](#)."

Enclosed you will find a report that meet the requirements stated above. The total number of intra-district students bused under the Chapter [220](#) designation for the school year 2006-2007 equals 15,837. Of that number 726 either did not return a consent form or checked box indicating no consent. Students who have moved during the school year and no longer require parental consent were subtracted from the non-returned figure. The district did meet the requirement of ninety-five percent (95%) parents providing consent.
