

IN ACCORDANCE WITH WIS. STAT. § 227.41, this Petitioner seeks a declaratory ruling on the current Canteen Catalog Program policy, requesting that it ruled to be invalid and contrary to DOC 309.52, Wis. Admin. Code, and subchapter II, Administrative Rules ch. 227, Wis. Stats.

The grounds for granting a declaratory judgment are set forth below:

CONTRARY TO DOC 309.52

1.) On January 1, 2008, John Bett (Division of Adult Institutions ["DAI"] Administrator) officially implemented the Canteen Catalog Program.

2.) The Canteen Catalog Program requires that all DOC inmates, and inmates' families, purchase inmate personal property items through only four pre-approved vendors/stores (Walkenhorst's Access Catalog Co., Union Supply, and Jack L. Marcus).

3.) Inmates' personal property items include: televisions, typewriters, shoes, clothing, etc....

4.) Prior to January 1, 2008, and the implementation of the Canteen Catalog Program, inmates, and inmates' families, were allowed to purchase inmate personal property items from any vendor/store

of their choosing (as long as the specific vendor/store was not prohibited by the DOC for security reasons).

5.) This Canteen Catalog Program is in direct conflict with the Wisconsin Administrative Code, as DOC 309.52(1)(d) reads, in part:

"Institutions shall permit inmates to purchase approved property not carried in canteen... The procedures shall permit purchases from a sufficient number of enterprises to ensure a reasonable selection and a competitive price."

6.) Each of the four pre-approved vendors provide a special Canteen Catalog (separate from the vendors' Regular Catalogs), which Wisconsin inmates, and inmates' families, are required to order from.

Walkenhorst's

7.) As an example, ~~Walkenhorst's~~ (based in California) lists the following items, in their Regular Catalog, as priced:

- Swintec 2410 Clear Typewriter \$199.97
- Brother Nylon Ribbon (for typewriter) \$ 7.97

Keep in mind that Wisconsin inmates, and inmates' families, are prohibited from ordering/purchasing items from the Regular Catalog.

In Walkenhorst's special Canteen Catalog-- available only to Wisconsin inmates, and inmates' families --the same exact items, with the same exact order #s, are priced as:

- Swintec 2410 Clear Typewriter \$239.99
- Brother Nylon Ribbon \$ 9.99

(see attached copies of individual pages showing examples above).

8.) When the Better Business Bureau contacted Mr. Dan Walkenhorst (presumed owner of Walkenhorst's) about why Wisconsin inmates and their families are forced to pay higher prices for items, Mr. Walkenhorst replied, in relevant part:

"... per Wisconsin's sale agreement with Walkenhorst's [] we are required [to] rebate approximately 5% of sales to each facility, and [] freight costs were to be factored into the price of the products rather than show as a separate item, plus other incidental items that we were requested to do in order to do business with the Wisconsin Department of Corrections. It is because of these policies and requests by the State that our prices are higher."

(see attached letter from Mr. Dan Walkenhorst).

9.) Such a practice/policy/agreement between Walkenhorst's and the Dept. of Corrections conflicts with the interests and intent set forth under DOC 309.52, which further reads:

"[P]urchases should not be limited to a small number of businesses. Allowing inmates to choose from a large number of businesses encourages inmates to compare prices, and this is important in developing responsible money management habits."

(see NOTE to DOC 309.52, Wis. Adm. Register No.629, 5/31/08).

10.) Limiting inmates and their families to choosing from only four pre-approved/contracted vendors is not a "large number of businesses". Also, as evidenced by the unreasonable price hikes enforced by Walkenhorst's and the DOC, such a policy contradicts the "competitive price" language used in DOC 309.52. (i.e., ordering a Swintec Clear Typewriter from Walkenhorst's Canteen Catalog would require me, as a private citizen, to pay \$40 MORE [not including tax] than I would if I were allowed to purchase the same item from the company's Regular Catalog).

11.) It must also be noted that a few of the four pre-approved vendors have a history of providing poor customer service, as well as providing subpar/defective products, to inmates. For example, as of 7/11/08, the Better Business Bureau has given the Access Catalog Co. an UNSATISFACTORY Rating.

(see www.reports.hurdmanvir.com, Reliability Report for Access Catalog Co.).

THIS RULE/POLICY HASN'T BEEN PROPERLY PROMULGATED

12.) A "rule" is a regulation, standard, statement of policy or general order of general application which has the effect of law and which is issued by an agency to implement, interpret or make specific legislation enforced or administered by the agency or to govern the organization or procedure of the agency. See Wis. Stat., 227.01(13).

13.) Although the Canteen Catalog Program hasn't been formally implemented in any DOC or DAI policy or rule, it still has the

effect of a "rule" given under Wis. Stat., ch. 227.


14.) This Canteen Catalog Program was simply initiated upon the dissemination of John Bett's memo, and was not, and still has not, been properly reviewed and authorized by Legislative Council Staff, as well as members of the Joint Committee for Review of Administrative Rules.

15.) Consequently, by failing to comply and adhere to the required rule-making procedures of Wis. Stat., ch. 227, the Canteen Catalog Program is invalid and must be immediately dissolved.

WHEREFORE, this Petitioner respectfully requests a declaratory ruling be issued which dissolves the Canteen Catalog Program, making it invalid. And in accordance with Wis. Stat. § 227.42, this Petitioner also demands that a hearing be held on this matter.

It is because of these policies and requests by the State that our prices our higher.

The catalog is also submitted to the Wisconsin Department of Corrections for approval before distribution to the facilities.
