Dear Senator Jeffrey Plale:

I am writing to you on behalf of the Wisconsin County Code Administrators (WCCA). WCCA is an Association of County Planning, Zoning and Sanitary Code Officials throughout the State of Wisconsin who are responsible for administering many land use and environmental health regulations.

WCCA supports Senate Bill 330.

This is a simple bill that makes changes in current law so that the phrase "private sewage system" is used consistently when referring to these systems. The changes proposed by the Wisconsin Department of Commerce will make it easier to interpret and administer Wisconsin Statute 145 as it relates to private sewage systems.

WCCA respectfully requests the Committee on Commerce, Utilities and Rail to support passage of this Bill.
