

Since moving to Green Bay in 2000, Celestine has become a part of the fabric of our community. She is committed to grassroots organizations, and to the advancement of all community members. She was the president and founder of the Ft. Howard Neighborhood Association, which is a volunteer group that works to maintain low crime rates while also building a sense of community and belonging. Celestine is committed to improving the housing stock of our downtown neighborhoods, and so in 2001, she joined the board of Neighborhood Housing Services, an organization which rehabilitates houses, and helps hundreds of people (many of them single women) purchase their first home. She is the board secretary and also a member of the Asset Management Committee. Celestine was a member of the Nia African Drumming and Dancing troupe, a truly multicultural group created to promote diversity while celebrating African and African-American culture. She coordinated the city's first Rainbow Children Arts Festival. Celestine is committed to increasing parental involvement in our schools. To that end, she is an active member of her sons' school (Aldo Leopold), served on the Parent Advisory Committee for the Green Bay Public Schools, is a member of the High School Task Force, and was invited to join DPI's Parent Leadership Corps.

In April of this year, Celestine became Green Bay's first African-American alderman. She is also the only woman currently serving on the City Council. She currently serves as the chair of the Improvement and Services Committee, vice chair of the Parks Committee, and a member of the Economic Development Authority.

Celestine is a graduate of the University of Chicago. She is married to Professor Derek Jeffreys, and is blessed with twin sons.
