**ASSEMBLY AMENDMENT 1,
TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO 2009 ASSEMBLY BILL 614**

February 2, 2010 – Offered by Representative RICHARDS.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 4, line 6: after that line insert:

3 “(br) “Health care information organization” means an organization that
4 gathers data from health care providers and hospitals regarding utilization and
5 quality of health care services and that produces reports on the comparative quality
6 of health care services provided by health care providers or hospitals.”.

7 **2.** Page 5, line 24: after that line insert:

8 “(am) A health care provider that submits data to a health care information
9 organization shall, when it makes a disclosure to a consumer under par. (a), provide
10 the consumer any information reported by the health care information organization
11 regarding the quality of health care services provided by the health care provider
12 compared to the quality of health care services provided by other health care

1 providers that is relevant to the health care service, diagnostic test, or procedure
2 specified by the consumer under par. (a). If the health care provider submits data
3 to more than one health care information organization and more than one of the
4 health care information organizations reports to the health care provider
5 comparative quality information that is relevant to the health care service,
6 diagnostic test, or procedure, the health care provider is required under this
7 paragraph to provide the consumer information reported by only one of the health
8 care information organizations.”.

9 **3.** Page 6, line 8: after that line insert:

10 “(bm) A health care provider that submits data to a health care information
11 organization shall include with the document required under par. (b) any
12 information reported by the health care information organization regarding the
13 quality of health care services provided by the health care provider compared to the
14 quality of health care services provided by other health care providers that is
15 relevant to a presenting condition for which the provider is required to list charge
16 information under par. (b). If the health care provider submits data to more than one
17 health care information organization and more than one of the health care
18 information organizations reports to the health care provider comparative quality
19 information that is relevant to a presenting condition, the health care provider is
20 required under this paragraph to include information reported by only one of the
21 health care information organizations for the presenting condition.”.

22 **4.** Page 6, line 11: after “par. (b)” insert “and the information described under
par. (bm)”.

1 **5. Page 6, line 22:** after “(b)” insert “and, if applicable, the information
described under par. (bm),”.

2 **6. Page 7, line 15:** after that line insert:

3 “(am) A hospital that submits data to a health care information organization
4 shall include with the document required under par. (a) any information reported by
5 the health care information organization regarding the quality of health care
6 services provided by the hospital compared to the quality of health care services
7 provided by other hospitals that is relevant to a diagnosis related group or outpatient
8 surgical procedure for which the hospital is required to list charge information under
9 par. (a). If a hospital submits data to more than one health care information
10 organization and more than one of the health care information organizations reports
11 to the hospital comparative quality information that is relevant to a diagnosis
12 related group or outpatient surgical procedure, the hospital is required under this
13 paragraph to include information reported by only one of the health care information
14 organizations for the diagnosis related group or outpatient surgical procedure.”.

15 **7. Page 7, line 17:** after “par. (a)” insert “and the information described under
par. (am)”.

16 **8. Page 7, line 24:** after “par. (a)” insert “and, if applicable, the information
described under par. (am),”.
