TO 2009 SENATE BILL 107**

June 17, 2009 – Offered by Representative STEINBRINK.

- 1 At the locations indicated, amend the bill, as shown by senate substitute
amendment 1, as follows:
- 2 **1.** Page 6, line 7: after “households” insert “or schools”.
- 3 **2.** Page 6, line 15: after “households” insert “or schools”.
- 4 **3.** Page 6, line 18: after “households” insert “or schools”.
- 5 **4.** Page 6, line 21: delete “consumer”.
- 6 **5.** Page 8, line 3: after “means” insert “ either a school electronic device or”.
- 7 **6.** Page 9, line 8: delete “and” and substitute “, schools, or”.
- 8 **7.** Page 9, line 15: after “households” insert “or schools”.
- 9 **8.** Page 9, line 21: after that line insert:
- 10 “(np) “School” means a public school, as defined in s. 115.01 (1).

1 (nr) “School computer or peripheral” means one of the following that is used by
2 a school:

3 1. A high-speed data processing device for performing logical, arithmetic, or
4 storage functions, except for an automated typewriter or typesetter, a portable
5 hand-held calculator or device, or other similar device.

6 2. A keyboard or any other device, other than a printer, that is sold for external
7 use with a device described in subd. 1. and that provides input into or output from
8 a device described in subd. 1.

9 (nu) “School electronic device” means a device that is one of the following,
10 unless the device is of a kind exempted by a rule promulgated by the department
11 under s. 287.17 (10) (i):

12 1. A school computer or peripheral.

13 2. A facsimile machine that is used by a school.

14 3. A digital video disc player that is used by a school.

15 4. A digital video player that does not use a disc, that is not a camera, and that
16 is used by a school.

17 5. A video cassette recorder that is used by a school.

18 6. A video recorder that does not use a cassette, that is not a camera, and that
19 is used by a school.

20 7. A school video display device.

21 8. Either of the following that is used by a school:

22 a. A desktop printer.

23 b. A device that prints and has other functions, such as copying, scanning, or
24 sending facsimiles, and that is designed to be placed on a work surface, but not a
25 calculator with printing capabilities.

1 9. Another kind of electronic device identified by the department under sub.
2 (10) (i).

3 (nw) “School video display device” means means a television or computer
4 monitor with a tube or screen that is at least 7 inches in its longest diagonal
5 measurement and that is used by a school, except that “school video display device”
6 does not include any of the following:

7 1. A television or computer monitor that is part of a motor vehicle and that is
8 incorporated into the motor vehicle by, or for, a motor vehicle manufacturer or a
9 franchised motor vehicle dealer.

10 2. A television or computer monitor that is contained within a clothes washer,
11 clothes dryer, refrigerator, freezer, microwave oven, conventional oven or stove,
12 dishwasher, room air conditioner, dehumidifier, or air purifier.”.
